CHAPTER 235—S. F. No. 36

An act relating to county welfare boards; amending Minnesota Statutes 1953, Section 393.03.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 393.03, is amended to read:

393.03 **Per diem.** Except as provided in section 393.01, subdivisions 3, 4 and 5, *each member* of the county welfare board *may* receive from the state, county, or a municipality, not to exceed \$10 for each day spent in transacting the business of the board, *but for not exceeding 25 days in any year. This compensation is in addition to any salary he may receive from any other source.* The county shall reimburse each member for expenses incurred in the performance of official duties.

CHAPTER 236—S. F. No. 359

An act authorizing the Commissioner of Conservation to convey certain interests in lands.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Sale, certain state lands.** The commissioner of Conservation of the State of Minnesota is hereby authorized on behalf of the State of Minnesota to convey to the owners of the land situated in Hennepin County, Minnesota, described as follows, to-wit:

Government Lot 1, Section 29; the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 28; and that part of Government Lot 3, in Section 28, lying Northerly and Westerly of the center line of Nine Mile Creek—all in Township 27 North, Range 24 West, and title registered

in the office of the Registrar of Titles, Hennepin County, Minnesota, under Certificate No. 67411,

any and all interests of the State of Minnesota in said land except the right of the State of Minnesota to construct and maintain a dam at the outlet of Nine Mile (Colman) Lake with a crest elevation not to exceed the natural ordinary high water level of said lake.

CHAPTER 237—S. F. No. 391

An act authorizing the Commissioner of Highways to employ consulting engineers for professional advice and preparation of plans for work on trunk highways; amending Laws of Minnesota 1953, Chapter 690.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws of Minnesota 1953, Chapter 690, is amended to read:

Section 1. **Registered professional engineers, employed by commissioner of highways.** The Commissioner of Highways is authorized to employ and engage the services of registered professional engineers to act as consultants in connection with, and to prepare plans and specifications themselves or by their organization and employees for the construction of trunk highways, and the commissioner of highways is authorized to negotiate for and agree upon the terms and compensation for such employment and services.

Sec. 2. This act shall take effect immediately upon its passage and shall continue *until July 1, 1957.*
