**Sec. 5. Appropriation.** There is hereby appropriated out of any funds not already appropriated the sum of \$22,200 to the commissioner of administration for the purpose of this act.

*An act appropriating money out of the state trunk highway fund for the payment of claims against the State of Minnesota which have been presented to and acted upon by the Minnesota State Claims Commission.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Appropriation, trunk highway fund, payment of certain claims.** There is hereby appropriated out of funds in the state trunk highway fund, or funds accredited thereto from highway patrol fines or other sources, not otherwise appropriated, the sums hereinafter specified for the purpose of paying claims against the State of Minnesota which have been presented to and acted upon by the Minnesota State Claims Commission, and which were reported to the legislature as provided by Laws of 1953, Chapter 749, Section 23, which claims are as follows:

*An act to appropriate funds out of the appropriation made to the University of Minnesota for the payment of claims against the State of Minnesota which have been presented to and acted upon by the Minnesota State Claims Commission.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Appropriation, University of Minnesota, payment of certain claims.** There is hereby appropriated to the University of Minnesota from any money in the treasury not otherwise appropriated the sums hereinafter specified to pay the claims against the State of Minnesota which have been presented to and acted upon by the Minnesota State Claims Commission, and which were reported to the legislature as provided by Laws of 1953, Chapter 749, Section 23, which claims are as follows:
