mail, to the last known address of the insured, and to any mortgagee to whom the policy is made payable.

CHAPTER 103—S. F. No. 658

An act relating to salries in certain towns; amending Minnesota Statutes 1953, Section 367.06, as amended.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1953, Section 367.06, as amended by Laws 1955, Chapter 313, Section 1, is amended to read:
- 367.06 Salaries. In any town within the following classifications, valuations being exclusive of money and credits, the electors, by a majority vote at any annual town meeting, after notice specifying that the matter is to come before the meeting, may fix the salaries of the chairmen and supervisors of the town board in amounts not less than as provided in section 367.05, nor more than the amounts authorized in this section. The amounts so fixed shall remain in effect until changed by like action of the electors. The classifications are:
- (1) In all towns having a population of 7,000 or more excluding the population of any cities or villages therein the salary of the supervisors may be \$100 each per month and the salary of the chairman may be \$150 per month;
- (2) In all towns having a population of more than 2,000 including the population of any village therein and an assessed valuation of more than \$10,000,000, and an area of 108 sections of land the salary of the supervisors may be \$250 per month and the salary of the chairman may be \$275 per month;
- (3) In all towns not included within the foregoing classifications, having a population of more than 2,000 and an assessed valuation of more than \$1,750,000, the salary of each supervisor may be \$35 per month and the salary of the chairman may be \$50 per month;
- (4) In all towns not included within any of the foregoing classifications having a population of more than 500 and an assessed valuation of more than \$1,000,000, the salary of

each supervisor may be \$50 per month and the salary of the chairman may be \$65 per month.

CHAPTER 104—S.F. No. 659

An act relating to powers and duties of town boards in certain towns; amending Minnesota Statutes 1953, Section 366.02.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 366.02, is amended to read:

866.02 Powers and duties. This section shall apply only to those towns now or hereafter having a population, including the population of all villages within such town not separated from the town for election and assessment purposes, exceeding 2,000, and not exceeding 10,000, and an assessed valuation, exclusive of money and credits, such that a tax levy of 17 mills upon the dollar of such assessed taxable valuation would produce a total levy in excess of an average of \$1,000 per governmental section of the entire area of such town, according to the government survey thereof. If any such town within this state comes within this classification it shall not thereafter cease to be governed by the provisions of this section, notwithstanding any change in valuation or population.

In addition to all other powers and duties provided by law, the town board, in such towns herein designated, shall have the power to:

- (1) Fix monthly salaries to be paid by the town to the town clerk, assessor and treasurer in lieu of the amounts otherwise provided by law to be paid by the town; provided the compensation so fixed shall not, in the case of the town clerk, exceed the sum of \$400 per month, in the case of assessor, shall not exceed the sum of \$100 per month; and, in the case of the treasurer, shall not exceed the sum of \$150 per month:
- (2) Employ when necessary clerical help, stenographers, or assistants to the town clerk;
- (3) Provide by resolution for the division of such town into not more than two voting districts for the purpose of electing town officers, and shall designate by resolution at
