CHAPTER 204—H. F. No. 1040

*An act relating to non-assessable improvements in cities of the first class having a population of not less than 300,000 nor more than 450,000 inhabitants.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **St. Paul, non-assessable improvements.** In any city of the first class having a population of not less than 300,000 nor more than 450,000 inhabitants, which city has a home rule charter providing for non-assessable improvements where the cost and expense of improvements such as change of grade for a street or alley, condemnation of land or an easement therein, the sum to be expended out of the general funds of such city shall not exceed the sum of \$750, notwithstanding any charter provision.

CHAPTER 205—H. F. No. 1042

*An act relating to street grading and the financing thereof in cities of the first class having a population of not less than 300,000 nor more than 450,000 inhabitants.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **St. Paul, street grading, appropriation.** In any city of the first class having a population of not less than 300,000 nor more than 450,000 inhabitants, which city has a home rule charter providing for an appropriation to be expended each year in paying the city's share of the cost of street paving, construction of trunk or main sewers and bridges, including right-of-way, there shall be added to such authority

the authority to expend such appropriation for the city's share in the cost of street grading projects. Such city shall have the authority to share the cost of such street grading projects when the cost of such projects exceeds the benefits which can be assessed against abutting property and when the projects will result in a public benefit. The projects for which such an appropriation may be made hereunder and the amount of the total appropriation for any one project shall be determined jointly by the department of finance and the department of public works of such city. No project shall be financed out of the appropriations of such city unless authorized by the governing body thereof.

CHAPTER 206—H. F. No. 1401

*An act relating to the state board of medical examiners, and providing for temporary certificates for graduate training in medicine, surgery and obstetrics under specified conditions and for specified purposes.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[147.16] Temporary certificate for graduate training.** The state board of medical examiners may grant, in its discretion, without examination, a temporary certificate for graduate training in medicine, surgery and obstetrics, to those applicants as furnish satisfactory proof that the applicant;

(1) Is 21 years of age or over,

(2) Is of good moral character,

(3) Has successfully completed a course in medicine, surgery and obstetrics at a medical school approved by the board or by an evaluating agency recognized by the board, and has received the degree of M.D., or M.B. therefrom, or has successfully completed a course in medicine, surgery and obstetrics at a medical school located outside of the United States and Canada and that such medical school is approved by the licensing authorities of the country in which such medical school is located and has received the degree of M.D., or M.B. therefrom,

(4) Is duly licensed to practice medicine in all of its branches in the state, territory or foreign country in which he
