

CHAPTER 245—S. F. No. 926

An act relating to the Minnesota potato development commission; amending Minnesota Statutes 1953, Section 21.36, Subdivision 3.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 21.36, Subdivision 3, is amended to read:

Subd. 3. Upon the filing of a petition with the commission signed by 25 growers residing in one area praying that such sections shall apply in all or a stated part of the area, such commission shall carry *seven days* public notice to be published in a legal newspaper in each county affected of the time and place within the area when and where such petition will be heard and determined by the commission. At the time and place so stated the commission shall meet and hear all persons interested for and against the granting of such petition. All growers interested may then appear and be heard upon all matters pertaining to the granting or denial of such petition. Thereupon the commission shall make and file an order finding the proposed area suitable or unsuitable to the application of such sections. Thereupon the commission shall give like published notice of a referendum to be held in such area to such growers and if approved by two-thirds of the growers voting at such referendum such area shall be deemed organized under such sections and such sections shall apply thereto. Such commission shall thereupon file an order finding such facts and such order shall be evidence of the facts so found. Such proceedings shall have no effect beyond the boundaries of the area wherein held.

CHAPTER 246—H. F. No. 892

An act relating to certain cities and villages; providing for compensation of certain officers.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Members of governing body, compensation.** The governing body of any city or village having an assessed valuation comprised of at least 25 percent iron ore may pay the members of such governing body a per diem in an amount

not to exceed \$15 per day nor \$75 per year for members of such governing body who are absent from the municipality in the performance of their duty as municipal officials.

CHAPTER 247—H. F. No. 966

[Coded]

An act relating to the powers of the county board as to the county aid road fund.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. 162.01 [Subd. 9.] **Moneys transferred to road and bridge fund.** After July 1, 1957, any money remaining in the county aid road fund of any county may be transferred by the county board to the county road and bridge fund. Money so transferred shall be used for the same purposes as other money in the county road and bridge fund.

CHAPTER 248—H. F. No. 1130

[Not Coded]

An act legalizing and validating certain detachments of land from villages.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Detachment of land legalized.** In all cases where a village in this state has heretofore adopted an ordinance detaching any land from such village, which land at the time of adopting such ordinance was not contiguous or adjacent to such village, such detachment ordinance is hereby legalized and validated notwithstanding any defect in the petition or petitions for detachment received and acted upon or any difference between the characteristics of the land so detached and the characteristics prescribed by statute for land in order to be eligible for detachment.

Sec. 2. **Remedial.** It is expressly found and determined that this act is remedial in nature, being necessary to preserve the efficient and orderly management of the affairs of such villages, and this act shall be in full force and effect from and after its passage and approval.
