CHAPTER 291—S. F. No. 1116

[Not Coded]

*An act authorizing the county board in certain counties to acquire land along public highways for roadside parks, the cost to be paid from the county road and bridge fund.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Counties, acquisition of land for roadside park.** The county board of any county having over 26,000 and less than 28,000 inhabitants according to the 1950 federal census, is hereby authorized and empowered to acquire by purchase, gift or eminent domain, land lying adjacent to or within 200 feet of any county or state aid road in the county, for roadside parks. The cost of acquiring the land, establishing, improving and maintaining such roadside parks shall be paid from the county road and bridge fund.

CHAPTER 292—S. F. No. 1136

*An act authorizing the commissioner of conservation to convey certain interests in lands.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Conveyance of land.** The Commissioner of Conservation of the State of Minnesota is hereby authorized on behalf of the State of Minnesota to convey to the Northern Pacific Railroad Company, owners of the land situated in Pope County, Minnesota, described as follows, to-wit:

A 12-ft. longitudinal access road extending upon those portions of the Railway Company's 100-ft. Little Falls and Dakota Branch, right-of-way in the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  SW $\frac{1}{4}$ ), Section Nine (9), and in the Northwest Quarter of the Northwest Quarter (NW $\frac{1}{4}$  NW $\frac{1}{4}$ ),

Section Sixteen (16), both in Township One Hundred Twenty-five (125) North, Range Thirty-eight (38) West of the Fifth Principal Meridian, more particularly described in agreement recorded in Book 5 of Miscellaneous Page 363, office of Register of Deeds, Pope County, Minnesota, filed for record the 18th day of May A.D., 1954, at 1:00 o'clock p.m., any and all interests of the State of Minnesota in said land created by said instrument.

CHAPTER 293—S. F. No. 1169

*An act relating to the salary of the mayor and council in certain cities of the fourth class.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Cities fourth class, salaries of mayor and councilmen.** In any city of the fourth class having a population of not less than 5,000 nor more than 10,000 and an assessed valuation of not less than \$1,500,000 nor more than \$3,000,000 and of which valuation more than 40 percent consists of iron ore, the council shall fix the salary of the mayor at not less than \$60 per month and that of the councilmen at not less than \$50 per month, notwithstanding any provision of the city charter to the contrary.

CHAPTER 294—S. F. No. 1165

*An act relating to fees of clerk of district court in title registration proceedings; amending Minnesota Statutes 1953, Section 508.81.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 508.81, is amended to read:

508.81 **Clerk's fees; notices.** In counties *having a population of less than 600,000 and containing a city of the first class*, on the filing of any application for registration, the
