

## CHAPTER 479—S. F. No. 1430

[Not Coded]

*An act relating to clerk hire in the office of auditor, treasurer and probate court in certain counties and amending Laws 1953, Chapter 317, Section 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1953, Chapter 317, Section 1, is amended to read:

Section 1. **Clerk hire, Winona county.** In any county in this state now or hereafter having a population of not less than 39,000, nor more than 42,000 inhabitants, according to the 1950 federal census and containing more than 19 and less than 23 full and fractional congressional townships and having an area of not less than 600 nor more than 700 square miles, the amount of annual clerk hire for the office of county auditor shall be \$11,000.00 and the amount of annual clerk hire for the office of county treasurer shall be \$7,000 and the amount of annual clerk hire for the office of the probate court shall be \$7,000, and such additional sums as may be allowed by the board of county commissioners.

CHAPTER 480—S. F. No. 1452

*An act relating to compensation of county commissioners in certain counties.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **County commissioners, certain counties, compensation.** The salary and compensation of each county commissioner in any county now or hereafter having a population of not less than 70,000 nor more than 100,000 shall be \$2,400 per year. In addition thereto each commissioner shall receive \$5.00 per day for each day necessarily occupied in the discharge of official duties while acting on any committee under the direction of the board, and 7½ cents for each mile necessarily traveled in attending meetings of the board or upon committee work. The total per diem and mileage paid to any commissioner in any year shall not exceed the sum of \$750.00. This total is in addition to his salary of \$2,400. The

chairman of the county board shall receive  $7\frac{1}{2}$  cents for each mile necessarily traveled in going to the county seat to sign warrants during recess of the board.

Sec. 2. This act shall take effect on July 1, 1957.

#### CHAPTER 481—S. F. No. 1462

*An act relating to drainage; amending Minnesota Statutes 1953, Section 106.231, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 106.231, Subdivision 1, is amended to read:

106.231 **Letting contract.** Subdivision 1. After the expiration of 30 days following the filing of the order establishing a drainage system, the auditor and the county board, in the instance of a county ditch, and the auditors of the respective counties, or a majority of them, in the instance of a judicial ditch, shall proceed to let the job of constructing the system. In judicial ditch proceedings the auditors shall hold the letting at the office of the auditor of the county in which the proceedings are pending.

#### CHAPTER 482—S. F. No. 1587

*An act authorizing the sale of certain lands in Roseau County by the commissioner of conservation.*

WHEREAS, the State of Minnesota by virtue of tax-forfeiture claims to be the owner of the following described trust fund land situated in Roseau County, Minnesota, to-wit: East One-half ( $E\frac{1}{2}$ ), Section 4, Township 163 North, Range 37 West, and

WHEREAS, Enger Lindgren likewise claims to be the owner thereof and is now in possession of the same and has made valuable improvements thereon in the belief that he was the owner of the same.
