

CHAPTER 484—S. F. No. 1615

[Not Coded]

An act relating to salary of register of deeds and members of the county board in certain counties.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Salaries, register of deeds, board members, certain counties.** After January 1, 1957, in any county having over 4,000 and less than 6,000 inhabitants according to the 1950 federal census, and having over 50 and less than 60 full and fractional congressional townships, the salary of the register of deeds shall be \$4,000 and the members of the county board \$1,100 per annum.

CHAPTER 485—S. F. No. 1659

An act relating to road and bridge tax levies in certain counties; amending Laws 1951, Chapter 238, Section 1, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1951, Chapter 238, Section 1, as amended by Laws 1955, Chapter 314, Section 1, is amended to read:

Section 1. **County road and bridge fund, levy.** In all counties having a population of not less than 28,000 nor more than 30,000 inhabitants according to the 1950 federal census and containing not less than 23 nor more than 25 full or fractional congressional townships, the county board at its July meeting may include in its annual levy not to exceed 25 mills for the county road and bridge fund. For the years 1958 and 1959 such counties may levy an additional five mills for the county road and bridge fund.

CHAPTER 486—S. F. No. 1732

An act regulating the importation of animals foreign to Minnesota.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. [17.45] Importation of European rabbit forbidden. [Subdivision 1.] It is unlawful for any individual, person, firm, partnership, or corporation to import into Minnesota the European rabbit, commonly known as the San Juan Hare, of *Cuniculus* species and the *Oryctolhus-Cuniculus* Genus, without obtaining permission from the commissioner of agriculture, dairy and food.

Sec. 2. [Subd. 2.] Any person violating this act is guilty of misdemeanor.

CHAPTER 487—S. F. No. 1781

An act relating to policemen's relief associations in certain cities of the fourth class, and to the creation, maintenance and administration of a police pension fund.

Be it enacted by the Legislature of the State of Minnesota :

Section 1. Police pension fund, cities fourth class. This act applies to all cities of the fourth class in this state which have a population according to the last federal census of more than 4685 and less than 4700, having an assessed valuation of \$2,480,000, situated in a county having 14 full townships. Any city which comes under the terms of this act shall continue thereunder notwithstanding any subsequent change in classification.

Sec. 2. Incorporate as policemen's relief association. The members of the police department in any such city may incorporate as a policemen's relief association pursuant to the provisions of any laws of the state and adopt articles of incorporation and by-laws as a relief association. All members of such department at the time of the taking effect of this act and all persons subsequently becoming members of such department shall be members of such association, except persons appointed for temporary service or for probationary periods.

Sec. 3. Sections applicable. A policemen's relief association so incorporated of any such city, when authorized by an ordinance approved or adopted by the governing body of such city, may adopt and operate under the provisions of Minnesota Statutes 1953, Sections 423.41 to 423.62 inclusive,
