

all small game hunting licenses a surcharge of \$1, which shall be added to such license fee, and which surcharge shall be free from any commissions and so stated on the back of the small game hunting licenses, together with the following statement: "This \$1 surcharge is being paid by sportsmen for the acquisition and development of wildlife lands."

Sec. 3. **Wildlife acquisition fund, established.** There shall be established in the state treasury a separate fund known as the "Wildlife Acquisition Fund" into which the proceeds derived from the surcharge shall be deposited and all monies so deposited shall be used by the Commissioner of Conservation for the purposes of this act, in accordance with appropriations made by the legislature.

Sec. 4. **Assessments to be paid from fund.** Any assessments against the State of Minnesota under the provisions of Minnesota Statutes, Section 106.381, or Laws 1955, Chapter 681, shall be paid from monies in the Wildlife Acquisition Fund herein created on all such lands or properties heretofore or hereafter acquired for wildlife habitat.

Sec. 5. **Effective date and expiration.** This act shall be effective upon its passage, and continue in effect until December 31, 1962.

CHAPTER 645—H. F. No. 1170

[Coded]

*An act to establish and dedicate Mille Lacs Kathio State Park in Mille Lacs County.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [85.122] [(1.)] **Mille Lacs Kathio State Park.** All state-owned lands now under the jurisdiction of the commissioner of conservation for conservation purposes, together with all lands now or hereafter forfeited for non-payment of taxes and any trust fund lands now or hereafter granted to the state, all of which are hereby withdrawn from sale, and which are located in Mille Lacs County within the limits hereinafter described, are hereby set apart and dedicated for park purposes, to-wit:

Sections Thirty-two (32) and Thirty-three (33), Town-

ship Forty-three (43) North, Range Twenty-seven (27) West, and

Sections Three (3), Four (4), Five (5), Eight (8), Nine (9), Ten (10), Eleven (11), Twelve (12), Thirteen (13), Fourteen (14), Fifteen (15), Sixteen (16), Seventeen (17), Twenty (20), Twenty-one (21), Twenty-two (22), Twenty-three (23), and Twenty-four (24), Township Forty-two (42) North, Range Twenty-seven (27) West.

Sec. 2. [(2.)] The lands so selected and dedicated within the limits specified in this act shall be known as the "Mille Lacs Kathio State Park", to be administered in the same manner as provided for other state parks and be perpetually dedicated for such use by the people of the state.

CHAPTER 646—H. F. No. 2087

*An act relating to standard time; amending Minnesota Statutes 1953, Section 645.07.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1953, Section 645.07 is amended to read:

**645.07 Uniform standard time. (Daylight saving).** Every mention of, or reference to, any hour or time in any law is to be construed with reference to and in accordance with the mean solar time of the ninetieth meridian of longitude west of Greenwich, commonly known as Central Standard Time. The standard of time in this state *shall be one hour ahead of such solar time each year beginning and ending on such dates established by the governor to the end that time in use in this state will be in practicable conformance with time other than standard time in use elsewhere in the nation* and no department of the state government and no county, city, town, village, or borough shall employ any other time or adopt any ordinance or order providing for the use of any other time than the standard time.

Sec. 2. *Any laws inconsistent herewith are hereby amended to the extent inconsistent herewith.*

Sec. 3. *This act is effective on passage and shall continue in effect until July 1, 1959.*
