under authority of this act, anything in said sections to the contrary notwithstanding. In event such properties are all owned by one person, it shall not be necessary to make any determination of the value thereof. In event such properties are owned by more than one person, the taxes shall be apportioned annually between them by the county auditor on the basis of the relative values thereof owned by each, upon such investigation of the facts as the auditor shall deem necessary. The taxes levied in accordance with this act shall be billed to and collected from such person or persons at the same time and in the same manner as taxes levied in and for such school district upon real property subject to taxation therein; provided, any portion of such taxes levied for the payment of installments of principal of such bonds may be paid without penalty on or before October 31 of the year in which such taxes became due and payable if such installments of principal is not due until more than 60 days thereafter.

- Sec. 3. Minnesota Statutes 1955, Chapter 514, Section 4, is amended to read:
- Sec. 4. Authority to issue bonds, expiration. Powers additional. The authority to issue bonds under this act shall expire on January 1, 1959. The powers granted hereby are in addition to and not a limitation upon any powers with respect to the subject matter hereof which any such school district may have under other laws.

# CHAPTER 67-S. F. No. 194

An act relating to workers' safety.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [614.68] Manufacture of certain products which may be injurious. [Subdivision 1.] It shall be unlawful for any person to manufacture for sale or distribution within the state any product to be used in water-proofing or curing cement which product may be injurious to the skin or eyes of the user unless there is specified on the container of such product the chemical composition thereof, a warning of possible injurious effect, and the antidote in the event of injury.

Sec. 2. [Subd. 2.] Violation of this act shall constitute a misdemeanor.

## CHAPTER 68-S. F. No. 272

#### [Not Coded]

An act to grant to the executive council power to extend certain timber permits upon the recommendation of the conservation commissioner.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Executive council, extension of timber permits. The executive council, upon application of the holders of any incompleted permits issued September 10, 1946, September 28, 1948, May 3, 1950, September 21, 1950, September 26, 1950, October 25, 1950, November 8, 1950, June 14, 1951, September 19, 1951, September 23, 1952, September 24, 1952, September 25, 1952, and September 26, 1952, may for good and sufficient reason and upon the recommendation of the conservation commissioner, extend the same for and during such period as the council deems advisable.
- Sec. 2. Conditions of permits. Any permit extended under the provisions of this act shall be subject to the charge of six per cent per annum interest on the entire unpaid purchase price and the destruction of the timber by any cause during the period of such extension shall not relieve the purchaser for payment of the same, and said purchaser shall be liable to the state therefor as provided for in Minnesota Statutes 1953, Section 90.11.

An act authorizing the commissioner of conservation to acquire certain interests in land for dam site and flowage purposes by gift, purchase, condemnation or otherwise; and to construct a dam and control works and other structures for the restoration of the water levels of Goose and Mud Lakes, Cass County, Minnesota; to contract with the United States
