

olution determines a special need or reason exists for the use of other facilities or personnel. Reimbursement for expenses incurred shall be made pursuant to the rules governing state employees.

**Sec. 3. Report.** The commission shall report its findings and recommendations to the 1959 session of the legislature.

**Sec. 4. Expenses.** Members of the commission and the advisory committees provided for in section 2, shall be reimbursed for expenses incurred in the performance of commission duties, within the limit of the appropriation provided. The commission is authorized to adopt rules and regulations for the conduct of its business, to purchase stationery and supplies and to employ an executive secretary, a reporter for the revision of the criminal laws, clerical assistance and such experts and assistants as it considers necessary for carrying out the provisions of this act, and to prescribe their duties.

**Sec. 5. Appropriation.** The sum of \$30,000 is hereby appropriated from moneys in the state treasury, not otherwise appropriated, to the commission for the purposes enumerated in this act.

## CHAPTER 836—S. F. No. 1684

[Not Coded]

*An act legalizing and validating certain deeds executed by officials of school districts.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Validating certain deeds executed by officials of school districts.** All deeds of real property heretofore made by the proper officials of any school district conveying real property within this state belonging to such school district which were recorded prior to January 1, 1922, in the office of the register of deeds of the county in which the real property conveyed is situated, and the record thereof, are hereby legalized, validated and confirmed, notwithstanding that the resolution authorizing the transfer was not recorded in the manner provided by law, or that the records of the school district do not disclose that the conveyance was authorized by the electorate of the school district as provided by law.

**Sec. 2. Application.** This act shall not apply to any action or proceeding now pending in any of the courts of this state wherein the validity of any such deed is being litigated or to any action which may be commenced within 60 days after the passage of this act wherein the validity of such deed is being questioned.

CHAPTER 837—S. F. No. 1713

*An act creating a commission to study and report on the laws relating to conservation and appropriating money therefor.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Legislative commission on conservation laws.** There is created a commission to be called the legislative commission on conservation laws. The commission shall consist of seven members of the senate to be appointed by the committee on committees and seven members of the house of representatives to be appointed by the speaker.

**Sec. 2. Duties.** The commission shall study and report on the various laws dealing with conservation, relating to game and fish, and concerning the operations and functions of the department of conservation. The commission shall make its findings and recommendations and prepare any necessary bills for introduction in the next legislature. It shall recommend means and methods of improving the operations and functions of the department of conservation and the laws relating to conservation.

**Sec. 3. Report.** Said legislative commission shall make its report to the governor and the sixty-first session of the legislature between November 15, 1958, and January 15, 1959.

**Sec. 4. Hearings.** For the accomplishment of its purpose and the performance of its duty the commission and its committees may hold hearings at such times and places as may be convenient for the purpose of receiving evidence, and the commission and its committees may issue subpoenas in the manner provided by its rules.

**Sec. 5. Expenses.** Members of the commission will
