reaches \$125,000, any levy for the ensuing year shall be only such as will be calculated to maintain this amount after all other income to the fund is deducted.

Sec. 2. Provided, however, that nothing in this act shall affect, or be intended to reduce, the minimums prescribed in Minnesota Statutes 1957, Section 423.807, Subdivision 2; nor shall this act affect or modify any of the provisions of Minnesota Statutes, Section 423.801 to 423.815, except as herein set forth applicable to the policemen's relief association and the policemen's pension fund of the city of Winona, and in no way affects said relief association operating in the manner provided in said sections 423.801 to 423.815.

Sec. 3. This act shall become effective only after its approval by a majority of the governing body of the city of Winona.

## CHAPTER 109-S. F. No. 534

[Coded]

An act relating to the powers of certain school boards, authorizing membership in certain organizations.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [125.52] Metropolitan School Board Association; membership. The board of any school district containing land area within 20 miles of any city of the first class may become a member of the Metropolitan School Board Association and appoint one or more of its members to attend the annual meeting. The amount of annual membership dues and actual and necessary expense incurred in attending such meeting shall be paid as other expenses of the district are paid.

## CHAPTER 110-S. F. No. 567

[Not Coded]

An act relating to the Town of Hermantown in St. Louis County; providing for the exercise of certain village powers with respect to a waterworks utility. Be it enacted by the Legislature of the State of Minnesota:

Section 1. Hermantown, town of, waterworks utility. The town of Hermantown in the county of St. Louis shall have the same powers with respect to a waterworks utility as are now possessed by villages under Minnesota Statutes 1957, Sections 412.321 to 412.391, and Minnesota Statutes 1957, Chapters 429 and 475, and acts supplementary thereto or amendatory thereof, unless otherwise provided in section 2.

Sec. 2. Subdivision 1. Obligations to finance the construction of all or any part of a waterworks utility which are payable wholly from the income from the waterworks utility may be issued only upon obtaining the approval of a threefifths majority of the electors voting on the question of issuing the obligations, notwithstanding the provisions of Minnesota Statutes 1957, Section 475.58.

Subd. 2. The town board is authorized to call a special town election on the question of the issuance of waterworks revenue bonds as provided in section 2, subdivision 1. At least three weeks published notice in one or more legal newspapers of general circulation in the town and at least three weeks posted notice shall be given of the special election, setting forth the question to be submitted. The notice shall state the maximum amount of such obligations to be issued and the purpose of the proposed issue. The polls shall be open from nine a.m. to seven p.m. In all other respects the election shall be conducted and the votes convassed as elections by ballot at a regular town office.

Sec. 3. This act shall become effective only after its approval by a majority of the town board of the town of Hermantown.

## CHAPTER 111-S. F. No. 576

An act relating to the City of Glencoe; providing for operation of a gas distribution business.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Glencoe, natural gas distribution. The city of Glencoe in McLeod county may establish and operate a natural gas distribution plant for supplying its needs and that
