

Sec. 2. All county officials herein referred to shall be entitled to and shall receive, in addition to the amounts specified in section 1 hereof, all cost-of-living increases hereafter allowed or allowable pursuant to the cost-of-living index as certified to the county auditor pursuant to Minnesota Statutes, Section 375.43.

Sec. 3. All other laws relating hereto, except Minnesota Statutes, Section 375.43, enacted either during this session or any time prior hereto shall be hereby in all ways repealed and rendered null and void.

Sec. 4. This act becomes effective upon its approval by the county board of Aitkin County.

CHAPTER 195—S. F. No. 329

*An act relating to the tax levy for county purposes in Sibley County.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Sibley County tax levy, county purposes.** The board of county commissioners of Sibley county may levy taxes annually for general revenue purposes on each dollar of taxable property, as assessed and entered upon the tax lists, for county purposes, not to exceed 15 mills.

Sec. 2. This act becomes effective only after its approval by a majority of the governing body of the county of Sibley.

CHAPTER 196—S. F. No. 330

*An act relating to tax levy for road and bridge purposes in the County of Sibley.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Sibley County, road and bridge tax levy.** The board of county commissioners of the county of Sibley

may levy a tax not to exceed 25 mills on the dollar of the taxable valuation of the county for road and bridge purposes.

Sec. 2. This act shall become effective only after its approval by a majority of the governing body of the county of Sibley.

CHAPTER 197—S. F. No. 419

*An act relating to certain county officers in Itasca County providing for validating cost of living salary adjustments.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Itasca County, county commissioners, county treasurer, and county sheriff.** Any excess payment of cost of living salary adjustments to the county commissioners, county treasurer, and county sheriff under the provisions of Minnesota Statutes 1957, Section 375.43, for the calendar years 1957 and 1958 and also in 1959 up to the date of the passage of this act as applied to the county commissioners, and for the calendar year 1958 and also in 1959 up to the date of the passage of this act as applied to the county treasurer, and as applied to the county sheriff for the calendar years 1953, 1954, and 1955 only is hereby approved and validated.

Sec. 2. **Effective date.** This act shall become effective only after its approval by a majority vote of the board of county commissioners of Itasca county.

*An act relating to official bonds of city officers and employees.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[418.25] Payment by city for official bonds.** Subdivision 1. When an officer or employee of any city, however organized, is required to furnish a fidelity or
