Sec. 2. This act becomes effective upon its approval by the governing body of the city of Saint Paul and the county of Ramsey.

CHAPTER 202-S. F. No. 622

An act relating to the salary of the county treasurer of Winona County and authorizing certain expenditures for employees therefor.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Winona County, treasurer's salary. In Winona county the county treasurer shall receive an annual salary fixed by the board of county commissioners at not to exceed \$8,400 to be paid in monthly installments.
- Sec. 2. Clerk hire, salary. The county treasurer of Winona county is authorized to hire such clerks as he shall reasonably need for such office and the board of county commissioners of Winona county shall fix the annual expenditure for such clerks at not to exceed \$10,000.
- Sec. 3. Effective date. This act shall become effective only after its approval by a majority vote of the board of county commissioners of Winona county.

CHAPTER 203-S. F. No. 674

An act relating to road and bridge tax levies in the County of Kandiyohi.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Kandiyohi County, road and bridge tax levies. In the county of Kandiyohi the county board at its July meeting may include in its annual levy not to exceed 25 mills for the county road and bridge fund. For the years 1960 and 1961 such county may levy an additional five mills for the county road and bridge fund.

Sec. 2. This act shall become effective upon approval by a majority of the governing body of the county of Kandiyohi.

CHAPTER 204—S. F. No. 739 [Not Coded]

An act relating to salaries and expenses of members of certain boards and commissions in St. Louis County.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. St. Louis County, certain board members, compensation. Notwithstanding the provisions of any law contrary thereto in St. Louis county, the members, except the members who are also members of the board of county commissioners, of all boards and commissions created by law shall receive for attending meetings of said board or commission \$20 per day but not to exceed \$600 in any one year, and each shall be repaid his necessary expenses for such attendance, a certified statement of which shall be filed with and approved by said board or commission.
- Sec. 2. The provisions of Section 1 shall become effective only after their approval by a majority vote of the members of the county board of St. Louis county.

CHAPTER 205-S. F. No. 770

An act relating to the salary of the county auditor in Traverse County.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Traverse County, auditor's salary. In the county of Traverse the county auditor shall receive a salary of not less than \$4,500 nor more than \$6,400 per annum as determined by the board of county commissioners, the salary so determined to be retroactive to January 1, 1959.
