CHAPTER 229-H. F. No. 706

An act relating to terms of district court in certain counties; amending Minnesota Statutes 1957, Section 484.11.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 484.11, is amended to read:

484.11 Certain counties in third judicial district. General terms of district court in the counties named in this section shall be held each year at the times herein specified:

Houston County: On the third Monday in May and the fourth Monday in October.

Olmsted County: The first Tuesday after the first Monday in September.

Wabasha County: On the third Monday in May and the second Monday in November.

Winona County: On the second Monday in January and the third Monday in April and September.

When any general term in any of said counties except Olmsted County shall be adjourned for a period of more than 30 days, and issues of fact in any action are joined more than eight days before the first day of any such adjourned term, then, and in that case, such action may be brought on for trial at such adjourned term upon notice of trial served eight days or more before the beginning of said adjourned term; such notice of trial shall be filed with the clerk at least eight days before the beginning of such adjourned term and shall serve as a note of issue.

An act relating to the salary of the county surveyor in certain counties; repealing Laws 1917, Chapter 456, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Repealer. Laws 1917, Chapter 456, as

amended by Laws 1919, Chapter 426, Laws 1943, Chapter 426, and Laws 1945, Chapter 566, is hereby repealed.

CHAPTER 231-H. F. No. 1439

An act authorizing the sale of certain state land.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Sale of state land. The commissioner of conservation is hereby authorized to offer for sale and to sell that portion of the NE¼ NW¼, Section 16-57-17 lying east of State Trunk Highway No. 53 in the same manner as provided by law for the sale of other state school trust fund lands, notwithstanding Minnesota Statutes 1957, Sections 92.07 and 92.45, and the Laws of 1945, Chapter 45. Provided that nothing herein contained shall be construed as authorizing the state to lease the mineral rights in the property herein described so long as Chapter 45, Laws of 1945, shall remain in effect as to said property herein described.

CHAPTER 232—H. F. No. 1435

An act authorizing the governor and the state auditor to convey to the County of Benton certain lands in Benton County for the purpose of clearing the title to said lands.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Benton County, conveyance of state land. The governor and state auditor are hereby authorized and directed to convey to the county of Benton, by a proper deed, attested by the secretary of state, the following described real estate situated in the village of Sauk Rapids, Benton County, Minnesota, to-wit: Lots One (1), Two (2), Eleven (11) and Twelve (12), Block Eighteen (18), Townsite (now village)
