visions into other sections or other subdivisions, or both, change reference numbers to agree with renumbered chapters, sections, or subdivisions, substitute the proper section, chapter, or subdivision numbers for the terms "this act," "the preceding section," and the like, substitute figures for written words and vice versa, and to substitute the date of the governor's approval for the words "the effective date of this act," and the like, and change capitalization for the purpose of uniformity, and correct manifest clerical or typographical errors.

He shall have power:

- (1) To correct therein all words misspelled in enrolments;
- (2) To correct all manifest grammatical and clerical errors, including punctuation, but no such correction shall constitute an alteration of, or a departure from, the enrolment; and
- (3) To transfer sections or subdivisions or to divide sections into other sections or subdivisions so as to give to distinct subject matters a section or subdivision number, but without changing the meaning.

An act relating to the Village of Nashwauk; providing for tax levies for police pensions; amending Laws 1943, Chapter 196, Sections 1, 6, and 7, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1943, Chapter 196, Section 1, is amended to read:

Section 1. This act applies to the village of Nashwauk.

Sec. 2. Laws 1943, Chapter 196, Section 6, as amended by Laws 1955, Chapter 88, Section 2, is amended to read:

- Sec. 6. Nashwauk, village of, police pension. For the support of the fund from which such pensions are paid the council or other governing body of the village shall each year, at the time the tax levies are made for the general revenues of the village, levy within the limits then permitted by law, a tax on all taxable property of the village in the amount of \$2,500 per annum, which levy shall be transmitted to the auditor of the county in which the village is located at the time the other tax levies are transmitted and shall be collected and the payment enforced in the same manner as other taxes of the village. In addition thereto each member of the association shall contribute to the fund each month five percent of his monthly pay, to be deducted at the time of the payment of his salary or wages by the village and transferred to the fund, in addition thereto, such relief association may transfer to such fund moneys raised from other sources and under the control of the association.
- Sec. 3. Laws 1943, Chapter 196, Section 7, as amended by Laws 1955, Chapter 88, Section 3, is amended to read:
- Sec. 7. If at any time the balance on hand in the fund, together with interest or other earnings accrued therein, exceeds the sum of \$30,000, then, as often as this occurs the levy of taxes for the fund shall be omitted for that year, and if at any time the whole amount of \$2,500 from taxation is not needed for the maintenance of the fund at \$30,000, then the sum to be raised by taxation shall be proportionately reduced to such amount as is sufficient to keep the fund at \$30,000.
