CHAPTER 369—S. F. No. 1570

An act authorizing the state and the City of Saint Paul to sell the other or exchange land in the state capitol area.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Exchange of land, state and city of St. Paul. Subdivision 1. The State of Minnesota, acting through the commissioner of administration, and the City of Saint Paul, acting through its council, may agree to and may sell to the other or exchange land within said city, to-wit: the city may agree to and may quitclaim to the state such interest as it may have in
 - (a) Those parts of Lots 2, 3, 4, 5, and 6, Block 2, Charles Bazilles addition to the City of St. Paul, and of Lots 26 and 27, Auditor's subdivision No. 10 St. Paul, Minn., and unused Thirteenth Street and Cedar Street bounded by the westerly line of Cedar Street, the southerly line of Columbus Avenue, the easterly line of Wabasha Street, and the northerly line of Twelfth Street as said streets are now improved, according to the plats thereof now on file and of Record in the office of the Register of Deeds in and for Ramsey County, Minnesota.
 - (b) Those parts of Lots 1, 2, 3, 18, 19, 20 and 21, except the easterly 3 feet of said Lots 18 and 19, Subdivision of Block Number One of Medill's Addition to the City of Saint Paul, that lie northerly of the northerly line of Twelfth Street as now improved and easterly of the easterly line of Cedar Street as now improved, according to the plat thereof now on file and of record in the office of the Register of Deeds in and for Ramsey County, Minnesota.

(c) A tract of land known as Central Park and designated as such on the plat of Central Park Addition to the City of Saint Paul, now on file and of Record in the office of the Register of Deeds in and for Ramsey County, Minnesota.

- (d) A tract of land known as the Old Capitol Site which was formerly a portion of Block 6, Bazil and Guerin's Addition to the City of Saint Paul, bounded on the north by Tenth Street, on the west by Wabasha Street, on the south by Exchange Street and the east by Cedar Street, in the City of Saint Paul, according to the plat on file and of Record in the office of Register of Deeds in and for Ramsey County, Minnesota.
- Subd. 2. The acquisition by the state shall be for any or all of the following uses: for additions to the capitol grounds, for parking areas for state officers and employees, as an armory site, or as sites for future state buildings.
- Subd. 3. The conveyance by the state shall be executed by the governor and attested by the secretary of state and by the city as is authorized by its charter. None of the lands described in Section 1, clause (d) shall be conveyed without the approval of the Adjutant General. The Adjutant General shall not approve any such conveyance until he is assured that the lands described in Section 1, clauses (b) or (c) are conveyed to the state and made available for an armory site in place of the lands described in Section 1, clause (d).
- Subd. 4. If the state finds it necessary to acquire any part of the land described in section 1 hereof by condemnation, the city may agree to and may release or return to the state its share of any condemnation award as consideration or partial consideration for any conveyance to it.
- Subd. 5. If any of said tracts are purchased or sold by the state the considerations therefor shall be such as are determined by negotiation between the commissioner of administration and the city council.
- Sec. 2. The state and the city may in like manner exchange other lands acquired by either pursuant to Law 1945, Chapter 315, known as the State Veterans Service Building Act.
 - Sec. 3. This act is only effective when approved by a

majority of the members of the city council of the City of Saint Paul.

CHAPTER 370—H. F. No. 1565

An act relating to snow removal on those highways and roads in Lake County lying within the superior national forest.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Lake County, highway snow removal. The board of county commissioners of Lake County is authorized to expend such moneys as are necessary for snow removal on those highways or roads which are located within the county and also within the boundaries of the superior national forest, and which are needed to permit public transportation of pupils to and from schools within the county.
- Sec. 2. This act shall be effective only after its approval by a majority vote of the board of county commissioners of Lake County.

CHAPTER 371-S. F. No. 605

An act providing for the flying of the state flag at the state capitol; amending Minnesota Statutes 1957, Section 1.141, by adding a Subdivision thereto.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 1.141, is amended by adding a new subdivision to read:

Subd. 5. State flag. The official state flag shall be flown on the state capitol grounds at all times between the hours of sunrise and sunset.
