An act relating to appeals from certain courts and the right to jury trials thereon.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [484.471] Appeal, jury trial on appeal. Subdivision 1. Any person convicted of a violation of a municipal ordinance in any court may appeal from the conviction to the district court in the same manner and with the same effect as provided by Minnesota Statutes 1957, Chapter 633, except that the appellant shall have the right to a jury trial.

CHAPTER 389—S. F. No. 1491

[Coded]

An act relating to towns, giving certain towns additional powers; amending Minnesota Statutes 1957, Section 368.01. Be it enacted by the Legislature of the State of Minnesota:

Section 1. [367.035] Assessors or treasurers; vacancies in certain towns. In any town any part of which lies within 25 miles of the city hall of a city of the first class, the governing body may fill by appointment any vacancy which may occur in the office of town assessor or any vacancy in the office of town treasurer; furthermore, upon filling any such vacancy by any such appointment, the governing body may provide such compensation for any such officer as such governing body may deem proper, any other law notwithstanding.

CHAPTER 390-H. F. No. 1744

An act relating to the closing of county court houses and the public offices therein on Saturdays and Sundays of each week and legalizing acts of officials on the next succeeding business day in Carlton County.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Carlton County, court house, business hours. The board of county commissioners of Carlton county may by resolution close the county court house or houses and the public offices therein on Saturdays and Sundays of each week. In the event the offices of the county are so closed, any and all business that might otherwise be transacted with any such offices on any such Saturday, including the payment of taxes, may be performed on the next succeeding legal business day without penalty or any loss of personal or property rights.
- Sec. 2. This law is effective after its approval by a majority of the board of county commissioners of such county.

CHAPTER 391-H. F. No. 1684

An act relating to Itasca County; mileage allowance for certain county employees.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Itasca County, mileage allowances. The county board of Itasca county may allow mileage, not to exceed ten cents per mile to any county employee whose duties cause undue or excessive wear to the motor vehicle operated by the employee.
- Sec. 2. This act takes effect when approved by a majority of the county board of Itasca county.
