An act authorizing the Commissioner of Conservation to convey certain interests in lands.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Conveyance of state land, Hennepin County. The Commissioner of Conservation of the State of Minnesota is hereby authorized on behalf of the State of Minnesota to convey to the owners of the land situated in Hennepin County, Minnesota, described as follows, to-wit:

That part of Government Lot 3, Section 29, Township 27 North, Range 24 West, which is platted as Lots 1 to 9 inclusive, and Lots 13 and 14, Questend, Hennepin County, Minnesota, which land is described in Document No. 178090 in the office of the Registrar of Titles, Hennepin County, Minnesota,

any and all interests of the State of Minnesota in said land as specified in Document No. 178090 filed for record with said Registrar of Titles on May 4, 1942, except the right of the State of Minnesota to construct and maintain a dam at the outlet of Nine Mile (Coleman) Lake with a crest elevation not to exceed the natural ordinary high water level of said lake.

CHAPTER 444-H. F. No. 565

An act relating to wild animals; defining unprotected species of birds and regulating the taking of other species; amending Minnesota Statutes 1957, Section 100.26, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 100.26, Subdivision 2, is amended to read:

Subd. 2. Unprotected species. The English sparrow, blackbird, crow, starling, magpie, cormorant and the great horned owl are unprotected wild animals, but all other birds,

CHAPTER 445-H. F. No. 381

An act relating to wild rice; prescribing requirements for watercraft and equipment used in harvesting the same; amending Minnesota Statutes 1957, Section 84.111, Subdivision 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 84.111, Subdivision 1, is amended to read:

84.111 Water craft used in harvest. Subdivision 1. It shall be unlawful to use, in harvesting wild rice in any public waters in this state, any water craft other than a boat, skiff, or canoe propelled by hand, which boat, skiff, or canoe may have a top width of not more than 36 inches and a length of not more than 18 feet, or any boat, skiff, or canoe other than one having a smooth round bottom and sides, with no ridges or protrusions thereon except a central keel, or any machine or mechanical device for gathering or harvesting the grain other than with flails not over 30 inches in length nor over one pound in weight, which flails must be held and operated by hand.

Sec. 2. Section 1 shall take effect July 1, 1963.
