or by a member of his immediate family if such entry took place on or after July 1, 1940, shall, notwithstanding the removal therefrom of such person, while on active duty with the armed forces of the United States and or his family under such conditions, be classified in class 3b or 3c, as the case may be, provided, that absence of the owner therefrom is solely by reason of service in the armed forces, and that he intends to return thereto as soon as discharged or relieved from such service, and claims it as his homestead. Every person who, for the purpose of obtaining or aiding another in obtaining any benefit under this subdivision, shall knowingly make or submit to any assessor any affidavit or other statement which is false in any material matter shall be guilty of a felony.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 144.169, Subdivision 1, is amended to read:

144.169 Fees; deposited with state treasurer. Subdivision 1. The applicant shall pay a fee of \$1 for each certified copy of a birth or death record or for a search of the files upon written request when no copy is made. Provided that a fee shall not be charged for any certified copy needed in connection with service in the armed forces or the Merchant Marine of the United States or in the presentation of claims to the United States Veterans Administration or the official veterans administation of any state or territory of the United States.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 36.05, is amended to read:

36.05 Deposits in general fund; revolving account. Subdivision 1. Disposal of fees. All fees collected under sections 36.03 to 36.24, except receipts derived from the quality egg program, shall be deposited in the state treasury and shall be placed in the "poultry improvement fund," available for and from which expense of the commissioner in earrying out the provisions of sections 26.03 to 26.24 shall be paid: general revenue fund. Receipts derived from the quality egg program established under Minnesota Statutes, Section 36.03, are appropriated annually to the commissioner to carry out the purposes and pay the expenses of the program.

Subd. 2. Stores for resale revolving account. The poultry industries division stores for resale revolving account is hereby created in the state treasury to enable the poultry industries division of the department of agriculture, dairy, and food to purchase stores for resale. The account consists of the amounts appropriated by Laws 1941, Chapter 521, Section 6, Item 8-b, and Laws 1943, Chapter 638, Section 6, Item 8-b, which amounts are hereby transferred to the account created by this subdivision. The account also consists of proceeds from the sale of stores, which proceeds shall be deposited in the account. All money in the account is appropriated annually to the commissioner for the purposes set forth in this subdivision. At the end of each fiscal year the unobligated balances in the amount in excess of \$2,500 shall be deposited in and for the benefit of the general revenue fund:
