

the contrary, the board of county commissioners of Lincoln county may increase the salary of the county auditor and the county treasurer of Lincoln county to an amount not to exceed \$6,950 per year, and may make the salary increase retroactive to January 1, 1961. This salary shall be subject to the provisions of Minnesota Statutes 1957, Section 375.43, and acts amendatory thereof, and shall be in addition to such compensation as is otherwise provided by law.

Sec. 2. This act takes effect when approved by a majority of the board of county commissioners of Lincoln county and upon compliance with Laws 1959, Chapter 368.

CHAPTER 149—S. F. No. 125

An act relating to negotiable instruments; inland bills of exchange; amending Minnesota Statutes 1957, Section 335.50.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 335.50, is amended to read:

335.50. **Inland and foreign bill.** *Subdivision 1.* An inland bill of exchange is a bill which is, or on its face purports to be, both drawn and payable within ~~this state~~ *the United States*. Any other bill is a foreign bill. Unless the contrary appears on the face of the bill, the holder may treat it as an inland bill.

Subd. 2. *For the purposes of subdivision 1 hereof, "United States" means the states, territories, dependencies, and possessions of the United States, the District of Columbia, and Puerto Rico.*

An act relating to the salary of the county treasurer of Clay county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Clay county, treasurer's salary.** Notwithstanding the provisions of any other law to the contrary, the board of county commissioners of Clay county may establish the salary of the county treasurer of Clay county at an amount not less than \$6,000 per year nor more than \$10,000 per year. This salary shall be in addition to fees which the Clay county treasurer is authorized by law to collect and retain.

Sec. 2. This act takes effect when approved by a majority of the board of county commissioners of Clay county and upon compliance with Laws 1959, Chapter 368.

CHAPTER 151—S. F. No. 232

An act authorizing Otter Tail county to levy moneys to match state funds appropriated for state parks.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Otter Tail county, tax levy, state parks.** The county board of Otter Tail county may levy not to exceed one mill on all the taxable property, real and personal, in Otter Tail county, and may appropriate and expend the proceeds thereof for the purpose of matching any appropriation made by the legislature for the acquisition of state park lands in Otter Tail county.

Sec. 2. This act shall become effective upon its approval by the majority of the members of the board of county commissioners of Otter Tail county and upon compliance with Laws 1959, Chapter 368.
