

westerly of and parallel to the north quarter line of said section 34 and 1169.0 feet southerly of the north line of said section 34; thence northerly on a line parallel to the north quarter line of said section 34, a distance of 1069.0 feet; thence westerly at right angles to the above described course a distance of 250.0 feet; thence northerly at right angles to above described course, 100.0 feet more or less to the north line of said section 34; thence easterly along the north line of said section 34, 729.0 feet more or less to the north quarter corner thereof and the point of beginning, including all riparian rights to the contained 20.4 acres more or less and subject to existing road easements.

Sec. 2. **Winona to maintain property.** The city of Winona shall use and shall maintain the property herein authorized for transfer, solely for public wayside, park and recreational and other cultural civic purposes.

Sec. 3. This act takes effect on July 1, 1961.

CHAPTER 182—H. F. No. 890

An act authorizing the state and the city of St. Cloud to exchange certain lands in Stearns county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Exchange of armory property.** Subdivision 1. The adjutant general, with the approval of the governor, may convey to the city of St. Cloud the state's interest in and to the building known as the old armory in the city of St. Cloud, Stearns county, Minnesota, including the site thereof, described as follows:

All of lot 9 and the north half of lot 8, in block "E" of the town (now city) of St. Cloud, according to the plat and survey thereof made by John L. Wilson and now on file and of record in the office of the register of deeds for Stearns county;

for such public use as the city may make thereof; provided the city of St. Cloud shall convey, by quitclaim deed, to the state of Minnesota, department of military affairs, such in-

terest as said city may have in and to the following described real estate situate in Stearns county, Minnesota:

Block 33, in Stearns Addition to the city of St. Cloud, according to the plat and survey thereof on file and of record in the office of the register of deeds for Stearns county;

this section to be effective upon its approval by a majority of the members of the governing body of the city of St. Cloud and upon compliance with Laws 1959, Chapter 368.

Subd. 2. The acquisition by the state adjutant general shall be for use in connection with the new armory in the city of St. Cloud.

Subd. 3. Minnesota Statutes 1957, Section 193.36, Subdivision 3, shall have no application to the disposition of the old armory and site in the city of St. Cloud.

CHAPTER 183—H. F. No. 1064

An act providing for a change of the name of Mound Springs recreation reserve to Blue Mounds state park.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. The name and designation of Mound Springs Recreation Reserve as described in Minnesota Statutes 1957, Section 85.18 (6) is changed to Blue Mounds state park.

Sec. 2. [482.28] **Blue Mounds state park.** The change of name and designation to Blue Mounds state park as contained in section 1 is substituted for the name and designation as contained in Minnesota Statutes 1957, Section 85.18 (6), and the revisor of statutes in compiling Minnesota Statutes shall substitute the name and designation as herein provided under said section wherever it appears.
