CHAPTER 191—S. F. No. 221

An act authorizing the conveyance of certain lands by the state to the city of Robbinsdale for certain purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Sale of certain lands by state to Robbinsdale. The governor upon recommendation of the commissioner of highways, on behalf of the state of Minnesota, shall transfer and convey by quit claim deed, in a form approved by the attorney general, to the city of Robbinsdale, the following described tracts or parcels of land located in Hennepin county, Minnesota:

That part of the northwest quarter of the northwest quarter (NW 1/4 NW 1/4) of Section 8, Township 29 north, Range 24 west, which lies northerly of the north line of 35th Avenue North, Robbinsdale, Minnesota, and between two lines run parallel with and distant 75 feet and 134 feet northeasterly of the following described line:

Beginning at a point on the northerly boundary of Lot 15, Block 1, Glenwood Terrace Addition to Robbinsdale, according to the plat thereof now on file and of record in the office of the Register of Deeds in and for Hennepin County, distant 44.74 feet easterly of the northwest corner thereof; thence run northwesterly parallel to and distant 34 feet northeasterly of the northeasterly boundary of West Broadway Avenue for 1448.4 feet; thence deflect to the right on a 1°30' curve (delta angle 18°33') for 500 feet and there terminating;
together with a triangular piece adjoining and northeasterly of the above described strip and southwesterly of the following described line: Beginning at a point on a line run parrallel with and distant 100 feet north-easterly of the above described line; distant 100 feet

northwesterly of its intersection with the north line of 35th Avenue North; thence run southeasterly to a point on the north line of said 35th Avenue North, distant 100 feet easterly of said intersection;

also together with a triangular piece adjoining and northeasterly of the first above described strip and westerly of the following described line: Beginning at a point on the north line of said section 8, distant 867.7 feet east of the northwest corner thereof; thence run southerly at right angles to said north section line to the northeasterly boundary of the first above described strip;

containing 1.40 acres, more or less.

That part of Government Lot 3, Section 5, Township 29 north, Range 24 west, which lies northeasterly of a line run parallel with and distant 75 feet northeasterly of the following described line:

Beginning at a point on the northerly boundary of Lot 15, Block 1, Glenwood Terrace Addition to Robbinsdale, according to the plat thereof now on file and of record in the office of the Register of Deeds in and for Hennepin County, distant 44.74 feet easterly of the northwest corner thereof; thence run northwesterly parallel to and distant 34 feet northeasterly of the northeasterly boundary of West Broadway Avenue for 1448.44 feet; thence deflect to the right on a $1^{\circ}30'$ curve (delta angle $18^{\circ}33'$) for 1236.7 feet and there terminating;

and southwesterly of the following described line:

Beginning at a point on the south line of said Government Lot 3, distant 867.7 feet easterly of the southwest corner thereof; thence north 33 feet; thence run northwesterly for 321.1 feet, more or less, to a point (said point being described as follows: From a point on the east side of Crystal Lake Road, distant 16 feet north of the south line of said Government Lot 3, run east for 134.92 feet; thence north 207.5 feet to said point); thence continue northwesterly along said course for 222.9 feet, more or less, to a point on the above described 75 foot parallel line;

containing 1.12 acres, more or less.

All that part of Government Lot 3, Section 5, Township 29 north, Range 24 west, lying northeasterly of Trunk Highway No. 52 as the same is now located and established; and within a distance of 15 feet on each side of the following described line:

From a point on the north line of Lot 15, Block 1, Glenwood Terrace Addition to Robbinsdale, distant 44.74 feet easterly of the northwest corner thereof, run northwesterly parallel to and distant 34 feet northeasterly of the northeasterly line of West Broadway Avenue for 1448.4 feet; thence deflect to the right on a $1^{\circ}30'$ curve (delta angle $18^{\circ}33'$) for 680.9 feet to the point of beginning of the line to be described; thence deflect to the right at an angle of $90^{\circ}00'$ with the tangent of said $1^{\circ}30'$ curve at said point for 68 feet; thence deflect to the left at an angle of $65^{\circ}00'$ for 222 feet and there terminating.

Sec. 2. Said conveyance shall be made to the city of Robbinsdale without monetary consideration upon such terms and conditions as may be mutually agreed upon by the commissioner of highways and the city of Robbinsdale relating to the maintenance of drainage facilities and entry ways onto highways.

Sec. 3. **Delivery of deed.** The deed provided for herein shall be executed and delivered as soon as practicable after the passage of this act.

CHAPTER 192—S. F. No. 411

An act relating to economic poisons; amending Minnesota Statutes 1957, Section 24.02, Subdivision 8; Section 24.072, Subdivision 1.
