- Subd. 4. Upon recommendation of a majority of any library board created under the provisions of subdivision 1, the governing body of such city or village may abolish such library board at the end of any fiscal year provided that such governing body shall simultaneously establish a successor library board of either five, seven or nine members by resolution or ordinance. In the event of such resolution or ordinance, the mayor, with the approval of the council, shall appoint a library board of the number of members as provided by said resolution or ordinance. If nine are appointed, three shall hold office for one year, three for two years and three for three years. If seven members be appointed, three shall hold office for one year, two for two years, and two for three years; if five be appointed, two shall hold office for one year, two for two years, and one for three years.
