"Exclusive liquor store" is an establishment used exclusively for the sale of intoxicating liquor, cigars, cigarettes, *ice*, all forms of tobacco, non-intoxicating malt beverages and soft drinks at retail, either on sale or off sale, or both; provided, that lunches may be sold in a liquor store located in a village containing less than 500 inhabitants and situated in any coun-

ty having a population according to the last federal census of not less than 49,000, nor more than 50,000, and having not less than 24, nor more than 25, full and fractional townships.
