

CHAPTER 283—S. F. No. 1005

An act relating to insurance policies and providing for renewal by certificate of endorsement.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [60.501] **Renewal or extension; necessity of new policy.** Any insurance policy terminating by its provisions at a specified expiration date or limited as to term by any statute and not otherwise renewable may be renewed or extended at the option of the insurer, at the premium rate then required therefor, for a specific additional period or periods by a certificate, and without requiring the issuance of a new policy more than once in any five-year period.

CHAPTER 284—S. F. No. 1235

An act relating to special school district No. 3; authorizing the levy of a one mill tax for school purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Special school district No. 3; tax levy.** There shall be levied annually upon the taxable property in Special School District No. 3, a tax of one mill on the dollar, to be known as the Special School Tax. The tax shall be placed in the current school fund.

Sec. 2. Section 1 is effective upon the approval by a majority of the members of the board of directors of Special School District No. 3, and upon compliance with Laws 1959, Chapter 368.

CHAPTER 285—H. F. No. 381

An act relating to insurance premiums for state employee dependents; amending Minnesota Statutes 1957, Section 15.37.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 15.37, is amended to read:

15.37 Group insurance; premiums. Subdivision 1. The state, through the board, may insure its officers and employees, *or their dependents*, or any class or classes thereof, under a policy or policies of group insurance covering life, health, accident, surgical benefits, and hospitalization insurance, or any one or more of such forms of insurance. The premiums required from time to time to maintain such insurance in force shall be paid by its insured officers and employees, and the auditor shall deduct from the salary or wages of each officer or employee who elects to become insured, on the officer's or employee's written order, the officer's or employee's share of such premiums, and issue his warrant therefor to the insurer.

Subd. 2. A like payroll deduction and remittance shall be made upon the written order of any such officer or employees who are, or become, subscribers under a contract with a nonprofit hospital service plan corporation as defined by law.

CHAPTER 286—H. F. No. 385

An act relating to local improvements and special assessments in certain municipalities; amending Minnesota Statutes 1957, Section 429.051, as amended by Laws 1959, Chapter 490, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 429.051, as amended by Laws 1959, Chapter 490, Section 1, is amended to read:

429.051 Apportionment of cost. The cost of any improvement, or any part thereof, may be assessed upon property benefited by the improvement, based upon the benefits received, whether or not the property abuts on the improvement and whether or not any part of the cost of the improvement is paid from the county state-aid highway fund, the municipal state-aid street fund, or the trunk highway fund.
