

CHAPTER 357—S. F. No. 1165

An act relating to port authorities and amending Minnesota Statutes 1957, Section 458.09, Subdivision 1, as amended by Laws 1959, Chapter 316.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 458.09, Subdivision 1, as amended by Laws 1959, Chapter 316, is amended to read:

458.09 Port authority commission, application to seaway port authority. Subdivision 1. A commission to be known as "Port Authority of _____" is hereby established in and for every city of the state which has, or shall have over 50,000 inhabitants and which is or shall be situated upon, or adjacent to, or which embraces or shall embrace within its boundaries, in whole or in part a port or harbor located on a navigable lake or stream. Sections 458.09 to 458.19 are expressly declared to be applicable to all such cities, whether now or hereafter existing under a charter framed and adopted under the Constitution of the State of Minnesota, Article 4, Section 36, or not. Those port authorities now or hereafter having jurisdiction over harbors located on the Great Lakes-St. Lawrence seaway system shall be known and are referred to in Sections 458.09 to 458.19 as seaway port authorities. *Any such* A port authority shall be a body politic and corporate in the State of Minnesota with the right to sue and be sued in the names above designated. *Any such* A port authority shall also be considered a governmental subdivision within the meaning of Minnesota Statutes, section 282.01. The exercise by any such authority or commission of any of its powers shall be deemed and held to be essential governmental functions of the State of Minnesota, but any such authority shall not be immune from liability by reason thereof.

CHAPTER 358—S. F. No. 1437

An act authorizing participation by the county of Morrison and the city of Little Falls in providing a municipal courtroom in the courthouse.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Morrison county; Little Falls; courthouse.** Morrison county and the city of Little Falls are authorized to join in the cost of remodeling the courthouse to the extent of providing therein a courtroom in addition to the courtroom of the district court. This second courtroom will be primarily for the municipal court of the city but also serve as an auxiliary courtroom for the district court. The terms of participation shall be established by agreement between the county board and the city council embodied in a joint resolution adopted by a majority vote of each body. The agreement will establish the financial contribution of county and city, the purpose of the courtroom as set out above, and that the courtroom after construction will be the property of the county and maintained by it but that it will be subject at all times to the use of the city for its municipal court without cost to the city other than its participation in its original cost as authorized by this act.

Sec. 2. This act shall be effective when it is approved by a resolution of the city council and a resolution of the county board, in each case adopted by a majority vote, and upon compliance with Laws 1959, Chapter 368.

CHAPTER 359—S. F. No. 1712

An act relating to Mille Lacs county, authorizing the welfare board thereof to require poor relief recipients or applicants for such relief to work on county projects for such relief.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Mille Lacs county; poor relief; work by recipients.** The county welfare board of Mille lacs county may require an applicant or recipient, as a condition of receiving relief as granted under Minnesota Statutes 1957, Chapter 261, to work on county projects, and said work relief means support or relief in wages or other compensation in cash or kind, paid for work under the following conditions:

- (a) that the recipients of work relief and the amounts
