is hereby withdrawn from sale and transferred from the custody, control, and supervision of the county board of said county to the commissioner of conservation, free from any trust in favor of the interested taxing districts, to be annexed to Lake Bronson State Park. The commissioner shall execute a certificate of acceptance of said land on behalf of the state for said purposes and transmit the same to the county auditor of said county for record as provided by law in the case of tax-forfeited land transferred to the commissioner by resolution of the county board for conservation purposes. Thereupon said land shall become a part of said state park under the supervision and control of the commissioner as provided by law. The boundaries of said park as heretofore established by law are hereby extended to include said land.
