CHAPTER 516—S. F. No. 1386

An act authorizing the department of employment security to lease space to any other department or agency of the state of Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Employment security building; lease of space.** The commissioner of the Minnesota department of employment security, with the approval of the commissioner of the department of administration, may lease portions of the state owned building known as the employment security building located at 309-311 Second Avenue South, Minneapolis, Minnesota, to any department or agency of the state and charge rent therefor on the basis of space occupied. Any lease made pursuant to this section shall be in such form as the attorney general shall prescribe.

Sec. 2. Notwithstanding the provisions of any other law to the contrary, all moneys collected as rent under the terms of any lease entered into pursuant to the provisions of section 1, shall be deposited in the state treasury and credited to the account known as the employment security administration fund.

Sec. 3. This act shall be effective upon its passage.

CHAPTER 517—S. F. No. 1388

An act relating to employment security; amending Minnesota Statutes 1957, Section 268.05, by adding a new Subdivision 6.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 268.05, is amended by adding a new subdivision to read:

Subd. 6. Advance on federal funds. (1) The governor is hereby authorized to make application as may be necessary to secure any advance of funds by the secretary of the treasury of the United States in accordance with the authority extended under section 1201 of the social security act, as amended.

(2) Any amount transferred to the Minnesota unemployment compensation fund by the secretary of the treasury of the United States under the terms of any application made pursuant to this subdivision shall be repayable, without interest, in the manner provided in sections 901 (d) 1, 903 (b) 2 and 1202 of the social security act, as amended.

Sec. 2. *This act shall become effective upon its passage.*

CHAPTER 518—S. F. No. 1403

An act relating to the city of Duluth, prescribing fees for filing, indexing, entering, and certifying certain instruments.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Duluth, city of; city clerk; fees.** Subdivision 1. Notwithstanding any other law to the contrary, the fee to be charged by the city clerk of the city of Duluth for the filing, indexing, entering, and certifying to the date of filing the following instruments shall be 50 cents:

(1) Any chattel mortgage or duplicate or certified copy thereof, or assignment or partial release or satisfaction thereof;

(2) Any report of chattel mortgage foreclosure sale;

(3) Any promissory note or conditional contract of sale, or copy of either thereof, or memorandum of oral contract, or partial release or satisfaction of either thereof;
