An act relating to the salary of the county auditor of Benton county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Benton county; salary of auditor.** In Benton county the county auditor shall receive an annual salary to be set by the county board not in excess of \$7,000.

Sec. 2. This act takes effect when approved by a majority of the county board of Benton county and upon compliance with Laws 1959, Chapter 368.

CHAPTER 723—H. F. No. 1920

An act relating to public buildings of the state of Minnesota; authorizing the construction, reconstruction, repair, and rehabilitation of certain buildings; reappropriating moneys heretofore appropriated for such purposes.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Public buildings; appropriation.** Subdivision 1. The amounts enumerated in subdivision 2 are all or part of the unexpended and unencumbered balances of moneys

The unexpended and unappropriated balances of moneys appropriated by Extra Session Laws 1959, Chapter 90, Section 2, Subdivision 27, Clauses (1) to (13) are hereby reappropriated to the commissioner of administration for the purpose of a Minnesota Youth Treatment Center to be constructed in a manner he deems desirable.

Sec. 3. Subdivision 1. The unexpended and unencumbered balances of the appropriations made by the laws enumerated in subdivision 2, or so much thereof as may be necessary, are hereby reappropriated to the commissioner of administration for the purpose of remodeling the carpenter shop and lumber storage into a vegetable preparation room, including a new service elevator and equipment for the kitchen at the Moose Lake State Hospital.
