

Sec. 3. **Minimum salaries, increases.** Each junior deputy clerk and each senior deputy clerk shall serve in his classification for one year at the minimum salary for that classification, and his salary shall be increased at the end of each year's service by \$300 until such salaries reach the maximum for such classification. Deputy clerks returning from active service in the armed forces of the United States shall receive automatic salary increases in the same fashion as though the time spent in said active service had been spent as a deputy clerk. With the approval of the judges senior deputy clerks may be started in that classification at a salary more than the minimum and may be granted raises in excess of \$300 per year by the clerk. All senior deputy clerks and junior deputy clerks receiving the maximum salary at the time of passage of this act shall continue to receive such maximum salary.

Sec. 4. **Retroactive.** The provisions of section 2 are retroactive to January 1, 1961. The salaries set forth in section 2 are payable out of the treasury of the city in semi-monthly installments.

Sec. 5. **Repealer.** Extra Session Laws 1959, Chapter 7, Sections 1 to 4 are repealed.

EXTRA SESSION

CHAPTER 45—S. F. No. 35

An act relating to the salaries and compensation of certain officials in the county of Hennepin; amending Laws 1951, Chapter 702, Section 1, as amended; and repealing Laws 1957, Chapter 950, Section 3, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1951, Chapter 702, Section 1, as amended by Laws 1953, Chapter 753, Section 1, by Laws 1955, Chapter 875, Section 1, by Laws 1957, Chapter 950, Section 1, and by Extra Session Laws 1959, Chapter 17, Section 2, is amended to read:

Section 1. **Hennepin county; officials' salaries.** In

the county of Hennepin, the county officers hereinafter named shall receive as full compensation for all services of every kind or nature performed as such officials stated annual salaries as follows, to-wit: county attorney, ~~\$12,500~~ *\$14,250*; county auditor, ~~\$10,100~~ *\$10,850*, and in addition thereto, the county auditor may receive any sum not more than \$500 which may be otherwise provided for services as a member of a municipal building commission; county superintendent of schools, ~~\$8,100~~ *\$8,850*; county surveyor, ~~\$10,100~~ *\$10,850*, and *the county surveyor shall be allowed and paid \$125 per month for use of his own automobile in the performance of his official duties*; county treasurer, ~~\$10,100~~ *\$10,850*; clerk of district court, ~~\$10,100~~ *\$10,850*; coroner, ~~\$8,800~~ *\$9,550*, and the coroner and deputy coroners shall be reimbursed for the use of their own automobiles in the performance of their official duties, on a mileage basis at the rate fixed by law; court commissioner, ~~\$10,100~~ *\$10,850*, and in addition thereto the court commissioner may retain fees received for performing marriage ceremonies without accounting for the same or turning them in to the county treasury; register of deeds and registrar of titles, where the two offices are held by one person, ~~\$10,100~~ *\$10,850*; sheriff ~~\$10,100~~ *\$10,850*. The board of county commissioners may fix the annual salary of each commissioner, which salary shall not exceed ~~\$7,500~~ *\$8,250* and such transportation and traveling expenses as allowed by provisions of Minnesota Statutes, Section 382.03. The salaries herein fixed shall be paid on county auditor's warrants in equal semi-monthly installments.

Sec. 2. *Laws 1957, Chapter 950, Section 3, as amended by Extra Session Laws 1959, Chapter 17, Section 3, is hereby repealed.*

Sec. 3. *This act shall become effective upon its approval by a majority of the governing body of the county of Hennepin and upon compliance with Laws 1959, Chapter 368.*
