

division 1. A pupil unit is the denominator used to compute the distribution of state aid. Pupil units for each resident pupil in average daily attendance shall be counted as follows:

(1) In an elementary school, for kindergarten pupils attending ~~half day sessions~~ throughout the school year sessions throughout the school year approved by the commissioner of education, one-half pupil unit and other elementary pupils, one pupil unit.

(2) In secondary schools, pupils in junior high school or a six-year high school and all other pupils in secondary schools, one and one-half pupil units.

(3) In area vocational-technical schools one and one-half pupil units.

An act appropriating money to pay certain persons bonuses for World War I, World War II and Korean service.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Veterans; bonuses, appropriations.** There is appropriated from any moneys in the state treasury credited to the veterans compensation fund the sums of money set forth in this section to the persons named herein in full payment of claims against the state for adjusted compensation arising from World War I, World War II and Korean services:

CHAPTER 79—S. F. No. 230

An act relating to public employees retirement association; providing for benefits for surviving spouse and dependent children; amending Minnesota Statutes 1957, Section 353.31, as amended by adding a new subdivision.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1957, Section 353.31, as amended by Laws 1959, Chapters 646, Section 1; 650, Sections 19, 20 and 47; and 651, Section 1; and Laws 1961, Chapter 467, Sections 1 to 4, is amended by adding a subdivision to read:

[Subd. 7.] *Fatal illness upon last working day, leave of absence. Whenever a member, upon proof satisfactory to the board of trustees, is determined by the board to have been afflicted with a fatal illness on his last working day prior to July 1, 1959, in a position covered by Minnesota Statutes 1957, Chapter 353, as amended, which illness rendered him disabled to the date of his death occurring not more than one year from his last working day, substantiated by certificate of his attending physician, and if by reason of mistake or inadvertence of his governmental employer no official authorized leave of absence for such illness was granted him; and if the board determines, upon appropriate proof, that the said employers intended and considered, notwithstanding lack of previous official action so providing, that he be on such leave for not more than one year by reason of said fatal illness, and if such member dies within one year after his last working day and prior to July 1, 1959, all of which is established by resolution of the governing body of the employing governmental unit, the surviving widow and dependent child or children is entitled retroactively to survivor benefits as provided by Minnesota Statutes 1957, Section 353.31, as amended, in the same manner and to the same extent as if said employee, as a member of said as-*
