

allocate a percentage of such sum for expenditure solely on those portions of each county's county state-aid highways located within cities, villages, and boroughs having a population of less than 5,000, according to the last federal decennial census; *or, if incorporated during the ten-year period between federal decennial censuses, according to their incorporation census.* The percentage so allocated shall equal the percentage that the total needs of the county state-aid highway system in such cities, villages, and boroughs bears to the total county state-aid highway needs in each county. Money so allocated shall be set apart and credited to the municipal account of each county.

CHAPTER 245—H. F. No. 333

*An act relating to public waters and the dumping of trash; amending Minnesota Statutes 1961, Section 616.163, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 616.163, Subdivision 1, is amended to read:

616.163 **Trash, dumping into public waters or on ice.** Subdivision 1. No person shall throw, dump or deposit or cause or permit to be thrown, dumped or deposited in any lake, stream, river, or any body of public water, or on the ice thereof, or on the lands adjacent thereto without the consent of the owners of such land, any trash, rubbish, garbage or other litter. *Without limiting the generality hereof, trash, rubbish and garbage shall include cans, bottles, fuel oil, ashes, chemicals, and waste food products.*

CHAPTER 246—H. F. No. 384

*An act relating to deductions made from annuity upon resumption of teaching by members of the Teachers Retirement Association, amending Minnesota Statutes 1961, Section 135.44, Subdivision 6.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 135.44, Subdivision 6, is amended to read:

Subd. 6. **Teachers retirement; deductions from annuities.** A teacher who has purchased an annuity under any provision of any retirement law applicable to schools and institutions covered by sections 135.01 to 135.18 and 135.31 to 135.55 *and acts amendatory thereof* and has thereafter resumed teaching in any school or institution to which such sections apply shall continue to receive payments in accordance with such annuity except that during any quarter in which his income from such teaching service exceeds the sum of ~~\$300~~ \$600; the amount in excess of ~~\$300~~ \$600 shall be deducted from the annuity payable for the quarter immediately following the quarter in which the excess amount was earned.

CHAPTER 247—H. F. No. 472

*An act relating to the powers and duties of port authorities in cities of the first class; amending Minnesota Statutes 1961, Section 458.16.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 458.16, is amended to read:

458.16 **Port authorities; powers and duties.** *Subdivision 1.* It shall be the general duty of any such port authority to promote the general welfare of the port district, and of the port as a whole; to endeavor to increase the volume of the commerce thereof; to promote the efficient, safe and economical handling of such commerce, and to provide or promote adequate docks, railroad and terminal facilities open to all upon reasonable and equal terms for the handling, storage, care and shipment of freight and passengers to, from and through the port.

*Subd. 2.* It shall further be the special duty of such port authority:

(1) To confer with any similar body created under laws of any state embracing within its boundaries any part of any port or harbor of which the port district forms a part, and in so far as agreement shall be possible to adopt in conjunction with said similar body a
