CHAPTER 175-H. F. No. 464

An act relating to wild animals; providing for the maintenance and operation of private fish hatcheries; authorizing the taking of fish therein without licenses; amending Minnesota Statutes 1961, Section 97.48, Subdivision 22.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 97.48, Subdivision 22, is amended to read:

Fish; taking from private hatcheries. The com-Subd. 22. missioner shall have the power to authorize the maintenance and operation of private fish hatcheries under such rules and regulations as the commissioner shall prescribe. No license shall be required of any person for taking fish by angling at a licensed private fish hatchery operated in accordance with the rules and regulations of the commissioner, or from an artificial pool containing only fish purchased from a private fish hatchery, provided the operator shall furnish to each person taking such fish a written certificate in such form as the commissioner shall prescribe, giving the number and description of the fish taken and such other information as the commissioner requires, whereupon such fish may be possessed, shipped, or transported within the state in like manner as fish taken by a resident under a license. Any person making a false statement in any such certificate shall be guilty of a misdemeanor and subject to the same penalties as prescribed for violations of section 97.55, subdivision 11.

CHAPTER 176-H. F. No. 518

An act relating to wild animals; prohibiting the taking of partridges or ruffed grouse during big game hunting seasons; otherwise providing for seasons for the taking and possession of upland game birds; amending Minnesota Statutes 1961, Section 100.27, Subdivision 5.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 100.27, Subdivision 5, is amended to read:

Subd. 5. Partridge; taking during big game season. Except as otherwise expressly provided, quail, partridges or ruffed grouse,

pheasants, prairie chicken or pinnated grouse, white breasted or sharp tailed grouse, Hungarian partridge or chukar partridge, may be taken and possessed, subject to all other provisions of chapters 97 to 102, only in such areas of the state and during such times between September 16th and November 30th, as the commissioner shall prescribe. *This provision is subject to the following exceptions:*

(1) The taking of partridges or ruffed grouse in any area during any open season for taking any species of big game therein with legal firearms is prohibited.

CHAPTER 177-H. F. No. 687

An act relating to senatorial and representative districts; prescribing the bounds of the eleventh district; amending Minnesota Statutes 1961, Section 2.14.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 2.14, is amended to read:

2.14 Legislative districts; eleventh district. The eleventh district shall be composed of the county of Blue Earth and shall be entitled to elect one senator and two representatives.

The representative districts shall be divided as follows:

The city of Mankato, as its boundaries existed on January 1, 1963, shall constitute one district and shall be entitled to elect one representative; and

The county of Blue Earth, except the city of Mankato as its boundaries existed on January 1, 1963, shall constitute one district and shall be entitled to elect one representative.

Sec. 2. Section 1 is in effect for the elections of representatives in 1964 for the 1965 regular session and thereafter.
