

## CHAPTER 204—H. F. No. 1079

*An act relating to the fees for examination by the commissioner of banks of certain financial corporations; amending Minnesota Statutes 1961, Section 46.13, Subdivisions 2, 3 and 4.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 46.13, Subdivision 2, is amended to read:

Subd. 2. **Fees; banks, trust companies.** In the case of state banks, trust companies or savings banks, for each examination, a fee consisting of \$70 plus an amount equal to ~~47.5~~ 19 cents for each \$1,000 of assets up to and including \$1,000,000, plus an amount equal to ~~nine~~ 11 cents for each \$1,000 of assets in excess of \$1,000,000 and not exceeding \$5,000,000, plus an amount equal to ~~4.5~~ seven cents for each \$1,000 of assets in excess of \$5,000,000 and not exceeding \$20,000,000, plus an amount equal to ~~3.3~~ three cents for each \$1,000 of assets in excess of \$20,000,000; and in the case of trust companies an additional amount equal to two cents for each \$1,000 value of properties held in trust for the benefit of others.

Sec. 2. Minnesota Statutes 1961, Section 46.13, Subdivision 3, is amended to read:

Subd. 3. **Fees; savings, building and loan associations.** In the case of savings, building and loan associations, for each examination, a fee consisting of \$45, plus an amount equal to ~~22~~ 24 cents per \$1,000 of assets up to and including \$1,000,000, plus an amount equal to ~~11~~ 14 cents per \$1,000 of assets in excess of \$1,000,000 and not exceeding \$25,000,000, plus an amount equal to ~~5.5~~ five cents per \$1,000 of assets in excess of \$25,000,000, provided that where the accounts of an association are insured by the Federal Savings and Loan Insurance Corporation and such association is subject to a dual examination by federal and state authorities, the fees shall be assessed at \$45, plus 50 percent of the schedule set forth above.

Sec. 3. Minnesota Statutes 1961, Section 46.13, Subdivision 4, is amended to read:

Subd. 4. **Fees; credit unions.** In the case of credit unions, for each examination; if the assets are less than \$2,000, a fee of \$16.50; if the assets are \$2,000 or more, a fee of \$33, plus an amount equal to \$1.10 per \$1,000 of assets up to and including \$100,000, plus an amount equal to 55 cents for each \$1,000 of assets in excess of \$100,000 and not exceeding \$500,000, plus an

amount equal to 28 cents for each \$1,000 of assets in excess of \$500,000, and not exceeding \$1,500,000, plus an amount equal to 17 cents for each \$1,000 of assets in excess of \$1,500,000. ~~and not exceeding \$3,000,000; plus an amount equal to 11 cents for each \$1,000 of assets in excess of \$3,000,000.~~

CHAPTER 205—H. F. No. 1122

*An act relating to the salaries of the county commissioners of Jackson county.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Jackson county; commissioners' salaries.** In the county of Jackson the yearly salaries of the members of the board of county commissioners shall be set by said board at a sum not to exceed \$2,350, which sum shall be payable in equal monthly installments. The provisions herein are retroactive to January 7, 1963.

Sec. 2. The aforesaid salary shall constitute the base salary and said county commissioners shall be entitled to any cost of living increase hereafter granted under the provisions of Minnesota Statutes, Section 375.43 and acts amendatory thereof or supplementary thereto.

Sec. 3. This act shall become effective only after its approval by the board of county commissioners of the county of Jackson and upon compliance with the provisions of Minnesota Statutes, Section 645.021.
