

CHAPTER 209—H. F. No. 892

[Not Coded]

An act relating to the salary of the clerk of district court in Big Stone county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Big Stone county, clerk of district court's salary.** In the county of Big Stone, the clerk of district court shall receive a salary of \$3,000 per year, the salary so determined to be retroactive to January 1, 1963.

Sec. 2. The aforesaid salary shall constitute the base salary and said clerk of court shall be entitled to any cost of living increase hereafter granted under the provisions of Minnesota Statutes, Section 375.43, and acts amendatory thereof or supplementary thereto.

Sec. 3. Nothing contained in section 1 shall be construed as limiting the right of such officer to collect and retain fees, per diem payments, or any other payment which he is now authorized to collect in addition to the stated amount of his monthly salary.

Sec. 4. This act is effective upon final enactment.

CHAPTER 210—S. F. No. 561

An act relating to the payment of a per diem allowance and mileage to members of the Blue Earth county library board.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Blue Earth county; library board.** Each of the members of the Blue Earth county library board shall be paid \$5 per diem, plus necessary mileage at the legal rate, when attending regular or special meetings of said board, such meetings not to exceed 12 in number annually; said payments to be made on verified accounts and payable out of the county library fund of the county by auditor's warrant after allowance by the county board.

Sec. 2. This act shall become effective only after its ap-

proval by a majority of the board of county commissioners of Blue Earth county, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 211—S. F. No. 1119

An act authorizing the governor and the state auditor to execute a perpetual easement to the city of Mankato for certain purposes in certain lands in Blue Earth county, Minnesota.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Conveyance of state land; Mankato.** The governor and the state auditor of the state of Minnesota are hereby authorized and directed to convey, by proper instrument, in a form approved by the attorney general, a perpetual easement, including the right of access, to the city of Mankato in certain real estate situated in Blue Earth county, Minnesota, described as follows:

All that part of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ and the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 19, Township 108 North, Range 26 West, contained within a strip of land 60' wide, the centerline being more fully described as follows:

Beginning at the center of Section 19, Township 108 North, Range 26 West, thence deflecting to the left 80° 50' from the east line of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 19, Township 108 North, Range 26 West a distance of 499.07 feet to a point, thence left on a 25 degree curve 180.40 feet (I 45° 06' R.231.01' T.95.93') thence on the forward tangent 149.94 feet, thence right on a 10 degree curve 181.70 feet (I 18° 10' R.573.72' T.91.73') thence on the forward tangent 197.16 feet, thence right on a 10 degree curve 180.80 feet (I 18° 05' R.573.72' T.91.31') thence on the forward tangent 5.30 feet to a point on the west line of the NE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 19, Township 108 North, Range 26 West, said point being 1,319.40 feet west and 218.78 feet south of the center of Section 19, Township 108 North, Range 26 West;

Also, all that part of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 19, Township 108 North, Range 26 West, contained within a strip of land 60 feet wide, the centerline being described more fully as follows: Beginning at the center of Section 19, Township
