

sota, on the first Tuesday in April of the years 1963, 1964, 1965, and 1966 and on such a day in each odd numbered year thereafter.

Sec. 2. In the elections to be held in 1963, 1964, and 1966, three directors shall be elected in each of said years for three year terms each; in the year 1965, two directors shall be elected for two year terms and one director for a four year term.

Sec. 3. In the election in 1967, five directors shall be elected for four year terms and in 1969, four directors shall be elected for four year terms. In such elections in each succeeding odd numbered year, the number of directors shall be elected for four year terms corresponding to the terms expiring.

Sec. 4. All such elections shall be held in the manner prescribed by law and the directors elected at each such election shall take office at the regular meeting of such school board meeting held in May next succeeding each such election.

Sec. 5. The governing body of said special school district No. 3 and the city council of the city of Duluth shall apportion the cost of each such election in such proportion and amount as said bodies shall agree upon.

Sec. 6. Special Laws 1891, Chapter 312, Section 2, and Laws 1933, Chapter 117, Section 1, as amended by Laws 1935, Chapter 236, as amended by Laws 1949, Chapter 159, Section 1, as amended by Laws 1951, Chapter 291, Section 1, are hereby repealed.

Sec. 7. This act shall become effective when it is approved by a majority of the governing body of special school district No. 3, Duluth, Minnesota, and upon compliance with Minnesota Statutes, Section 645.021.

#### CHAPTER 254—H. F. No. 1088

*An act relating to the jurisdiction and powers of the port authority of the city of Saint Paul with reference to recreation and recreation facilities.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **St. Paul port authority; recreation facilities.** The

port authority of the city of Saint Paul shall have jurisdiction over the use of the Mississippi River for recreation purposes within its port district and may acquire and may expend port authority moneys for lands abutting upon said river within said port district for the purpose of constructing, operating directly, by lease or otherwise, and maintaining recreation facilities and shall establish regulations controlling the use of said river and abutting lands, either individually as such port authority, or in cooperation with the United States Government or its agencies, the city of Saint Paul, the state of Minnesota and any of said state's agencies or political subdivisions. The port authority shall not have any police power by virtue of this act, nor shall it take lands owned, controlled, or used by the city of Saint Paul without consent of the council of the city of Saint Paul.

Sec. 2. This act is passed in lieu of and substitution for those provisions on the same subject contained in Minnesota Statutes 1961, Section 458.16, in the paragraph numbered (8).

Sec. 3. This act shall become effective upon approval by a majority of the members of the board of commissioners of the Port Authority of the City of Saint Paul and by a majority of the members of the common council of the city of Saint Paul, and upon compliance with the provisions of Minnesota Statutes 1961, Section 645.021.

CHAPTER 255—S. F. No. 1206

*An act authorizing the city of Marshall to acquire by purchase, gift, or condemnation lands necessary for a city hall.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Marshall, city of; acquisition of land.** The city of Marshall in Lyon county may acquire by purchase, gift, or condemnation all lands deemed necessary by the common council for a city hall. In acquiring land for such purpose by exercising the power of eminent domain, the city may proceed under Minnesota Statutes 1961, Chapter 117, and shall have all rights of possession and entry conferred in other cases of condemnation by Minnesota Statutes 1961, Section 117.20, Subdivision 7.

Sec. 2. This act shall become effective only after its ap-
