CHAPTER 28—H. F. No. 65

*An act relating to the county of Fillmore, tax levy for road and bridge fund.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Fillmore county; road and bridge tax levy.** Notwithstanding the provisions and limitations of Minnesota Statutes, Section 163.05, Subdivision 4, and Laws 1961, Chapter 107, the board of county commissioners of the county of Fillmore may levy a tax not to exceed 25 mills on the dollar of the taxable valuation of the county for the county road and bridge fund.

Sec. 2. This act shall become effective only after its approval of the majority of the members of the board of county commissioners of the county of Fillmore, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 29—H. F. No. 122

*An act relating to the village of Plymouth; authorizing increased tax levies for storm sewer and storm drainage.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Plymouth, village of; drainage tax levies.** The village council of the village of Plymouth may levy, in addition to any other millage limitation, a tax of five mills on the dollar of the assessed valuation of all taxable property in the village for storm sewers and storm drainage. The levy of such tax shall not cause the amount of

other taxes levied or to be levied by the village, which are subject to any limitation, to be reduced in any amount whatsoever.

Sec. 2. This act shall become effective only after its approval by a majority of the governing body of the village of Plymouth, and upon compliance with the provisions of Minnesota Statutes 1961, Section 645.021.

CHAPTER 30—H. F. No. 128

*An act authorizing the village of Spring Grove to lease its hospital facility as a nursing home or hospital or both.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Spring Grove, village of, hospital facilities, lease.** Any hospital facility now or hereafter owned by the village of Spring Grove including buildings and equipment may be leased to a private person or corporation upon such terms and conditions as may be mutually agreeable to the village and such person or corporation. Any lease may provide for operation of such hospital facility for a nursing home or hospital or both.

Sec. 2. This law shall become effective only after its approval by a majority of the members of the village council of the village of Spring Grove, and upon compliance with Minnesota Statutes, Section 645.021.
