

CHAPTER 393—H. F. No. 788

An act relating to the licensing of operators of motor vehicles, amending Minnesota Statutes 1961, Section 171.02.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 171.02, is amended to read:

171.02 Drivers licenses; surrender of other licenses. No person, except those hereinafter expressly exempted, shall operate or drive any motor vehicle upon any street or highway in this state unless *such person* has a valid license as a driver under the provisions of this chapter. *No person shall receive a driver's license unless and until he surrenders to the department all valid driver's licenses in his possession issued to him by any other jurisdiction. All surrendered licenses shall be returned by the department to the issuing department together with information that licensee is now licensed in new jurisdiction. No person shall be permitted to have more than one valid driver's license at any time.*

CHAPTER 394—H. F. No. 814

An act relating to game and fish, authorizing the taking of sucker eggs from public waters for private fish hatchery purposes; amending Minnesota Statutes 1961, Section 98.46, Subdivision 17.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 98.46, Subdivision 17, is amended to read:

Subd. 17. **Sucker eggs; taking from public waters.** Fees for the following licenses, to be issued to either residents or nonresidents, shall be:

(1) To deal in live or engage in the business of preserving minnows; local minnow dealer, \$2.50.

(2) To raise fish in a private hatchery, \$5.

(3) *To take under state supervision sucker eggs from public waters, for private fish hatchery purposes:*

(a) *To take not to exceed 100 quarts, \$50;*

(b) *To take in excess of 100 quarts, \$1 per quart for such excess.*

CHAPTER 395—H. F. No. 832

An act relating to the department of health and the state board of health; amending Minnesota Statutes 1961, Section 144.01.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 144.01, is amended to read:

144.01 Department of health; continuation; membership. *The department of health as created and constituted under Laws of Minnesota 1925, Chapter 426, is hereby continued under the supervision and control of the state board of health. The state board of health shall consist of nine members, learned in sanitary science, who shall be appointed by the governor for such periods that the terms of three members will end on the first Monday of January in each year. Vacancies therein shall be filled by like appointment for the unexpired term and. Each member shall serve until his successor qualifies.*

CHAPTER 396—H. F. No. 927

An act relating to credit unions, providing a date for filing reports; amending Minnesota Statutes 1961, Section 52.06.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 52.06, is amended to read:

52.06 Credit unions; supervision; reports; audits; revocation of certificate of approval; fees. Credit unions shall be under the supervision of the commissioner of banks. Each credit union shall annually, on or before ~~the fifteenth day~~ of January 25, file a report with the commissioner of banks on forms supplied by him for that purpose giving such relevant information as he may require concerning the operations during the preceding calendar year.
