CHAPTER 480-S. F. No. 393

[Coded]

An act relating to public assistance; permitting counties and county welfare boards to file a lien for medical, surgical and hospital expenses paid or guaranteed by them.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [393.10] Public assistance; medical, surgical and hospital expenses, lien. [Subdivision 1.] Any county board or any county welfare board which as a part of its public assistance program provides, pays for or becomes liable for medical, surgical or hospital care shall have a lien for the cost of such care upon any and all causes of action accruing to the person to whom such care was furnished, or to the legal representatives of such person, on account of injuries giving rise to such causes of action and which necessitated such medical, surgical or hospital care, subject, however, to any attorney's lien.

Sec. 2. [Subd. 2.] Such county board or county welfare board may protect its lien pursuant to sections 514.69, 514.70 and 514.71.

CHAPTER 481—S. F. No. 834

An act relating to the state college board; permitting allocation of compensation to purchase retirement annuities for employees; authorizing deposit of funds in the state treasury; and appropriating money therefrom.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [136.55] State colleges; board may purchase Subdivision 1. At the request of an employee the state annuity. college board may negotiate and purchase an individual annuity contract from a company licensed to do business in Minnesota for an employee for retirement or other purposes and may allocate a portion of the compensation otherwise payable to the employee as salary for the purpose of paying the entire premium due or to become due under such contract. The allocation shall be made in a manner which will qualify the annuity premiums, or a portion thereof, for the benefit afforded under section 403 (b) of the current federal internal revenue code or any equivalent provision of subsequent federal income tax law. The employee shall own such contract and his rights thereunder shall be nonforfeitable except for failure to pay premiums.

Subd. 2. All amounts so allocated shall be deposited in an annuity account which is hereby established in the state treasury. There is annually appropriated from the annuity account in the state treasury to the state college board all moneys deposited therein for the payment of annuity premiums when due or for other application in accordance with the salary agreement entered into between the employee and the state college board. The moneys in the annuity account in the state treasury are not subject to the budget, allotment, and incumbrance system provided for in Minnesota Statutes, Chapter 16, and any act amendatory thereof.
