

CHAPTER 614—S. F. No. 1626

An act relating to the salary of the judge of probate court of Pennington county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Pennington county probate court; judge's salary.** The annual salary of the judge of probate court of Pennington county is \$7,200, notwithstanding the provisions of Minnesota Statutes 1961, Section 525.081, Subdivision 1.

Sec. 2. The provisions of Minnesota Statutes 1961, Section 525.081, Subdivision 2, shall apply to the salary provided in section 1.

CHAPTER 615—S. F. No. 1676

An act relating to the Minnesota state art society; changing its name and making certain changes in related laws; amending Minnesota Statutes 1961, Sections 139.01, 139.02, 139.03, 139.04, and 139.05.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 139.01, is amended to read:

139.01 **Objects; membership; reports.** The Minnesota state art society *arts council* shall advance the interest of the ~~fine~~ arts, develop the influence of art in education, and ~~foster its introduction into manufactures and all moneys and property received by it shall be devoted solely to these ends and promote and encourage the performing and fine arts in Minnesota.~~ The ~~society council~~ shall report in writing biennially to the governor. Its membership shall consist of a governing board and such ~~non-voting~~ members as may meet conditions of membership to be prescribed by the board. No member shall receive compensation as such, *but shall be reimbursed for expenses actually and necessarily incurred in the performance of duties hereunder.* ~~The works of art acquired by the society shall be the property of the state.~~

Sec. 2. Minnesota Statutes 1961, Section 139.02, is amended to read:

139.02 **Governing board.** The governing board of the *society council* shall consist of the governor and the president of the state university, as ex officio members, and 11 other members appointed by the governor by and with the advice and consent of the senate each for the term of four years and until his successor qualifies *from among individuals well known for their competence in the fields of the performing and fine arts.* ~~Included among such appointees there shall at all times be four artists or connoisseurs of art; one architect; one person prominently identified with education.~~ Vacancies shall be filled by appointment by the governor.

Sec. 3. Minnesota Statutes 1961, Section 139.03, is amended to read:

139.03 **Organization; powers and duties.** The board shall elect annually from its own members a president, a vice president, a secretary, and a treasurer, who shall serve as such officers of both the board and the *society council*; the last two offices may be held by the same person. Five members shall constitute a quorum. The board shall direct the affairs of the *society council* and, within the limitations of this chapter, it shall hold, manage and dispose of all funds and property received by the *society council*. It may adopt bylaws and rules governing the proceedings and business of the *society council* and may appoint committees and do all other things necessary to accomplish the purposes of the *society council*. ~~It shall act as an advisory committee in the selection of works of art purchased by the state and of designs for state public buildings.~~

Sec. 4. Minnesota Statutes 1961, Section 139.04, is amended to read:

139.04 **Powers and privileges.** The *society council* may acquire money or property of any kind by *purchase, hire, gift, or bequest,* and it may purchase works of art produced by artists born or living in this state; ~~provided that no one artist shall be paid in any year more than \$500 in addition to the costs of materials and casting of any sculpture purchased from him or grant from any individual, corporation, fiduciary or governmental agency, state or federal.~~ ~~In so~~ acquiring works of art, it may select them from the annual exhibition at the state fair or other exhibitions or sources. The society may hire any works of art for exhibition purposes. The works of art acquired by the society shall be made available for the education and enjoyment of the people of the state through lending them singly or in groups, for stated periods or indefinitely; for exhibition in suitable places throughout the state; including educational and cultural institutions; libraries; hospitals and any buildings owned, controlled or occupied by the state or any of its political subdivisions. Any institu-

tion or municipality receiving any such exhibition or loan may be required to pay such share of the society's costs and expenses as the governing board in its discretion may determine to be fair and reasonable. *The council may expend its funds in any way that the board shall determine so as to accomplish the objects of the council.*

Sec. 5. Minnesota Statutes 1961, Section 139.05, is amended to read:

139.05 Expense authorized. The ~~society~~ *council* may incur and pay all expenses reasonably necessary for properly selecting, preserving, transporting and exhibiting all works of art that it may require.

CHAPTER 616—S. F. No. 1681

[Coded in Part]

An act relating to municipal courts; fixing the salary of a judge and special judge of the municipal court of Maplewood when such court is organized.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Maplewood municipal court; judges' salary.** Subdivision 1. When and if a municipal court is organized in the Village of Maplewood pursuant to 1961 Minnesota Statutes, Chapter 488, the salaries of the judge and the special judge shall be as herein provided.

Subdivision 2. The annual salary of the judge of the municipal court in the Village of Maplewood is \$3,000.00.

Subdivision 3. The salary of any special judge of such municipal court is as provided in 1961 Minnesota Statutes, Section 488.22.

Sec. 2. In the event that the municipal court of the Village of Maplewood is organized as a joint municipal court in connection with one or more adjoining municipalities pursuant to 1961 Minnesota Statutes, Sections 488.31 to 488.37 inclusive, the salary of the municipal judge for such joint municipal court shall be an amount equal to the salary established by this act, plus the salary established by 1961 Minnesota Statutes, Section 488.21 for the existing court of any municipality which may be included in the agreement whereby such joint municipal court is organized.
