

Sec. 3. Notwithstanding the provisions of Minnesota Statutes 1961, Section 488.30, the county of Washington shall pay to the city of Stillwater for the operation of the municipal court of Stillwater the sum of \$1,900 annually to be paid \$950 every six months with the first such sum due and payable July 1, 1963 and a like amount every six months thereafter, provided, however, that the county may contribute such additional amount as it deems advisable.

Sec. 4. In the event that another municipal court shall be organized in the county of Washington then all of the provisions herein shall be null and void and the annual salary of the judge of the municipal court of Stillwater shall be \$3,600.

Sec. 5. Nothing herein shall be construed so as to invalidate the provisions of Minnesota Statutes 1961, Section 488.13.

Sec. 6. If any provision of this act shall be held unconstitutional or invalid for any reason the remaining provisions of the act shall remain valid.

CHAPTER 744—S. F. No. 1749

An act relating to Ramsey county; providing for the payment of certain fees in adoption matters in the juvenile court.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Ramsey county; adoptions; fees.** In adoption cases filed in the Juvenile Court for the Second Judicial District in Ramsey County the Clerk shall charge and collect the following fees, which shall be paid into the Treasury in the same manner as other fees are paid:

Second and additional copies of Decree	.50
Clerk's Certificate	.50
Photostatic copies of proceedings	1.00
for first page, and	.50
for each additional page.

CHAPTER 745—S. F. No. 1786

An act authorizing Ramsey county to expend funds for a morgue facility.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Ramsey county; morgue. Subdivision 1. The Board of County Commissioners of Ramsey County may expend any funds in the Ramsey County Treasury not otherwise encumbered in an amount not to exceed \$150,000 for the purpose of erecting and equipping a new morgue facility.

Subd. 2. This authority is in addition to and not a limitation upon any other authority of said board and is exempt from any taxing limit upon said board.

Sec. 2. This act shall take effect upon its approval by the Board of County Commissioners of Ramsey County, and upon compliance with Laws 1959, Chapter 368.

CHAPTER 746—S. F. No. 1868

An act relating to the municipal court of the city of Minneapolis; providing for compensation of court reporters; amending Minnesota Statutes 1961, Section 488A.05, Subdivision 3; and repealing Extra Session Laws 1961, Chapter 11, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 488A.05, Subdivision 3, is amended to read:

Subd. 3. **Minneapolis municipal court; court reporter's salary.** The annual salary of each reporter is ~~\$5,800~~ \$8,240 and is payable in semimonthly installments by the city treasurer from any funds in the city treasury not otherwise appropriated.
