

Section 1. Laws 1963, Chapter 728, Section 1, is amended to read:

Section 1. **Ramsey County League of Municipalities; additional members.** The cities of Saint Paul and White Bear Lake, the villages of Arden Hills, Falcon Heights, Gem Lake, Little Canada, Lauderdale, Maplewood, Mounds View, New Brighton, North Oaks, North St. Paul, Roseville, Shoreview, and Vadnais Heights, and the town of White Bear, are hereby empowered to participate in the organization of a Ramsey County League of Municipalities and to be members thereof. Each such municipality may appropriate through its governing body, out of its general fund, money to pay the annual dues in such league and the actual and necessary expenses of such delegates as such governing body may designate and to contribute to the funds of such league to be used for research and other projects of similar nature relating to problems common to the several municipalities participating therein, provided, however, that the total amount of money paid by any such municipality to such league, as dues, contributions or otherwise shall not exceed five cents per capita based on the population of each respective municipality according to the last federal census; and further provided, however, the maximum cost for membership fees or league dues on the part of any municipality shall not exceed the sum of \$1,250 *and the minimum amount of such dues shall be \$50.00.* Each such municipality has the powers and duties provided by Laws 1961, Chapter 728, for members of this league.

Sec. 2. *This act is effective as to a specific city, village or town named herein upon approval thereof by a majority of the governing body of such specific city, village, or town, and upon compliance with the provisions of Minnesota Statutes, Section 645.021. For the purposes of this section the governing body of the town herein named is the town board.*

CHAPTER 578—H. F. No. 2072

An act relating to a tax levy in the city of Minneapolis for the firemen's relief association; amending Laws 1963, Chapter 318, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1963, Chapter 318, Section 1, is amended to read:

Section 1. **Minneapolis, city of; firemen's relief.** The governing body of the city of Minneapolis shall each year at the time the tax levies for the support of the city are made, and in addition thereto, levy a tax on all taxable property within the city in an amount to pay the estimated pension costs due and payable by the Minneapolis fire department relief association pursuant to law for the year said pension costs are to be paid, less the proceeds or moneys paid into the special fund of such association pursuant to the provisions of Minnesota Statutes 1961, Chapter 69, or any other provision of law, during said year. Said tax shall in no event exceed $4\frac{3}{4}$ two mills. Should the estimated payments from the Minneapolis fire department relief association fund be of such amount as to require a levy in excess of $1\frac{3}{4}$ mills, the contributions by firemen provided for in Minnesota Statutes, Section 69.361, paragraph 1, shall in that such year be increased from $3\frac{1}{2}$ percent to $4\frac{1}{2}$ percent. *Should the estimated payments from the Minneapolis fire department relief association fund be of such amount that the two mill levy is insufficient to enable them to meet such payments, then the contributions by firemen provided for in Minnesota Statutes, Section 69.361, paragraph 1, shall in such year be increased from $4\frac{1}{2}$ percent to 5 percent.* The tax so levied shall be transmitted with other tax levies to the auditor of the county in which the city of Minneapolis is located and shall be collected and payment thereof enforced when and in like manner as state and county taxes are paid. All moneys collected under such levy shall be credited to the special fund of the association. This levy shall not be considered a part of the tax levy under any limitation in the charter of the city of Minneapolis, but shall be in addition to any existing charter or statutory limitation.

Sec. 2. *This act shall become effective only after its approval by the governing body of the city of Minneapolis and upon compliance with Minnesota Statutes, Section 645.021.*
