CHAPTER 5—H. F. No. 21

*An act relating to natural resources and recreation; appropriating moneys in connection therewith; amending Laws 1963, Chapter 790, Article X, Section 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1963, Chapter 790, Article X, Section 1, is amended to read:

Section 1. **[86.61] Natural resources and recreation; appropriations.** All moneys expended pursuant to any appropriation made by this act are subject to the provisions of Minnesota Statutes 1961, Chapter 16, and any act amendatory thereof. *None of the provisions of this section however shall apply to any appropriation made to the Minnesota outdoor recreation resources commission established by Laws 1963, Chapter 790, Article II, Section 2.*

Sec. 2. *The sum of \$25,000 is appropriated from the natural resources fund in the state treasury to the Minnesota outdoor recreation resources commission. This appropriation is in addition to the appropriation made to such commission by Laws 1963, Chapter 790, Article VIII, Section 2.*

Sec. 3. *This act is in effect from and after its final enactment.*

CHAPTER 6—H. F. No. 59

*An act authorizing the city of Moorhead to establish and maintain a department of business development.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Moorhead, city of; department of business development.** Subdivision 1. The city of Moorhead may establish and maintain a department of business development to carry out the following powers, duties and functions:

- (1) Research and statistics;
- (2) Publicity and promotion;
- (3) Business and industrial development services;
- (4) Publish and circulate information and facts concerning the recreational facilities and business and industrial conditions of the Moorhead area;
- (5) Promote and encourage the expansion and development of markets for Moorhead products;
- (6) Promote a coordinated community program in furtherance of business development.
- (7) Confer and cooperate with cognizant state and federal agencies.

Sec. 2. The city of Moorhead may provide for an annual allocation of funds up to the sum of \$25,000 per year with which to establish and maintain the department subject to such conditions and limitations as the city council shall prescribe. The said sum of up to \$25,000 per year may be made available from the revenue of any city owned and operated utility or may be provided for by a tax levy not to exceed in any one year four mills on the dollar of the assessed valuation on all the taxable property in the city. The authority herein contained shall not be limited by any charter limitation or any other limitation.

Sec. 3. This act shall become effective only after its approval by the city council of the city of Moorhead and upon compliance with the provisions of Minnesota Statutes, Section 645.021.
