CHAPTER 345—H. F. No. 1256

An act relating to the municipal court in the village of Pine Island; providing for the judge thereof acting as a court of conciliation.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Pine Island municipal court; conciliation court.** Minnesota Statutes 1961, Chapter 491, relating to a municipal court acting as a court of conciliation shall apply to the village of Pine Island and its municipal court, in like manner as such chapter applies to any city.

CHAPTER 346—H. F. No. 1307

An act providing persons violating provisions of Section 100.29, Subdivisions 10 or 11, while in possession of a bow or other implement capable of killing big game, guilty of a gross misdemeanor; amending Minnesota Statutes 1961, Section 97.55, Subdivision 9.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 97.55, Subdivision 9, is amended to read:

Subd. 9. **Wild animals; lights; use in locating.** Every person violating the provisions of section 100.29, subdivisions 10 or 11, relating to using an artificial light to locate wild animals, while in possession of a firearm, *bow or other implement*, capable of killing big game animals, or knowingly transporting a big game animal il-

legally taken, or provisions relating to buying or selling deer or buying fur bearing animals or raw furs shall be guilty of a gross misdemeanor.

CHAPTER 347—H. F. No. 1606

An act authorizing the city of Minneapolis to provide by ordinance or resolution for the payment of its employees by check forwarded through the United States Mail and waiving any requirement for signing the payroll by the employee.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Minneapolis, city of; pay checks.** Notwithstanding the provisions of any charter or statute to the contrary, the governing body of the city of Minneapolis or the governing body of any board of said city that has independent legislative powers may provide by ordinance or resolution that following its approval of the payroll, payment thereof to any employee under its jurisdiction shall be made by check and that the employee's endorsement on the back of such check shall constitute a receipt therefor in full compliance with any charter provision requiring the employee to receipt by signing the payroll; and further provided that such check may be forwarded to the employee by depositing the same in the United States mail.

Sec. 2. This act shall become effective only after its approval by a majority of all the members of the governing body of the city of Minneapolis and upon compliance with the provisions of Minnesota Statutes, Section 645.021.
