CHAPTER 462—S. F. No. 1078

[Not Coded]

An act providing for the salary for the county attorney of Anoka county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Anoka county; salary of attorney.** Notwithstanding the provisions of any other law to the contrary, the county attorney shall receive such compensation for services rendered by him as fixed by the county board, provided that the same shall be reasonable. The annual salary of the county attorney shall be paid in semimonthly payments upon the warrant of the county auditor drawn upon the county revenue fund.

Sec. 2. The county shall pay any bonds required of said office.

Sec. 3. All prior salary payments authorized by the board of county commissioners of Anoka county and paid to the county attorney in absence of statutory authority are hereby legalized and made valid.

Sec. 4. This act is effective upon its approval by a majority of all of the members of the county board of Anoka county, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 463—S. F. No. 1122

An act relating to the annual salaries of the board of county commissioners of McLeod county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **McLeod county; commissioners' salaries.** The board of county commissioners of McLeod county may set the annual salary of each county commissioner at a sum not to exceed \$2,500, which sum shall be paid in equal monthly installments. These salaries shall be in addition to such compensation as is otherwise provided by law.

Sec. 2. The salary as provided in section 1 shall constitute a base salary and the board of county commissioners may adjust such salary on the basis of the cost of living index as provided in Minnesota Statutes, Section 375.43.

CHAPTER 464—S. F. No. 1252

An act relating to taxes on and measured by net income and providing for the collection thereof; amending Minnesota Statutes 1961, Sections 290.48, Subdivision 2; and 290.92, Subdivision 6, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes, 1961, Section 290.48, Subdivision 2, is amended to read:

Subd. 2. **Income tax; collection; levy and sale.** If a tax imposed by this chapter, or any portion of such tax, is not paid within 30 days after it is required to be paid thereunder, the commissioner shall issue his warrant to the sheriff of any county of the state commanding him to levy upon and sell the real and personal property of the taxpayer and to levy upon the rights to property of the taxpayer within the county, and to return such warrant to the commissioner and pay to him the money collected by virtue thereof by a time to be therein specified, not less than 60 days from the date of the warrant. The sheriff shall proceed thereunder to levy upon and seize any property of the taxpayer and to levy upon the rights to property of the taxpayer within his county, except the homestead and household goods of the taxpayer; and property
