

CHAPTER 467—S. F. No. 1823

An act relating to Olmsted county; authorizing the board of county commissioners to issue bonds to finance an addition to the county hospital.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Olmsted county; hospital bonds.** Olmsted county is authorized, by resolutions of its county board and without an election, to construct, furnish, and equip an addition to its county hospital and to issue bonds payable from the net revenues of the hospital, for which the full faith and credit of the county may also be pledged, in a principal amount not to exceed \$450,000. The bonds shall be authorized, issued, and sold in accordance with Minnesota Statutes 1961, Chapter 475, except as otherwise provided in this act.

Sec. 2. This act takes effect when approved by the county board of Olmsted county and upon compliance with Minnesota Statutes, Section 645.021.

An act relating to fees for the Clerk of District Court in Ramsey county; repealing Laws 1903, Chapter 333, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Ramsey county; Clerk of District Court; fees.** Subdivision 1. The following scheduled fees for the services indicated shall apply for services rendered by the Clerk of District Court in the County of Ramsey:

Answer, Civil Action — for each separate appearance, filing.....	\$6.00
Answer, Land title registration, filing.....	\$8.00
