Subdivision 1. On or before October 1 of budget, financial aid. each year the commission shall adopt, after a public hearing, a budget covering its anticipated receipts and disbursements for the ensuing year and shall decide upon the total amount necessary to be raised from ad valorem tax levies to meet its budget. After adoption of the budget and no later than October 1, the secretary of the commission shall certify to the auditor of each county within its metropolitan area the county share of such tax, which shall be an amount bearing the same proportion to the total levy agreed on by the commission as the assessed valuation of the county bears to the assessed valuation of the metropolitan area. The maximum amount of any levy made for the purpose of this chapter shall not exceed 13/100 of a mill on each dollar of assessed valuation of all taxable property in the metropolitan area, provided however a maximum levy of one fifth of a mill may be made for the years 1965 and 1966.

- Subd. 2. The commission shall make a report of its finances and activities biennially to the legislature. CHAPTER 502—H. F. No. 625

An act prohibiting misrepresentation of the species of fish sold by a licensed fish peddler; providing penalty for violation; amending Minnesota Statutes 1961, Section 98.46, Subdivision 19.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1961, Section 98.46, Subdivision 19, is amended to read:
- Subd. 19. Fish; sale; misrepresentation of species. Fees for the following licenses, to be issued to either residents or non-residents, shall be:
- (1) To buy fish from licensed commercial fishermen on Lake Superior:

- (a) For the purpose of selling to retailers, \$25;
- (b) For the purpose of retail selling only, \$5.
- (2) To buy fish from licensed commercial fishermen on Lake of the Woods, Namakan, Sand Point, or Rainy Lake:
 - (a) Wholesale fish buyer's license, \$100;
- (b) Fish buyer's license to ship from one place to another on international waters only, \$10.
 - (3) To tan or dress raw furs, \$2;

(4) Fish peddler's license, to peddle with the use of a motor vehicle, any fish lawfully salable within the state, \$5. It shall be unlawful to misrepresent the species of any fish sold by any licensed fish peddler or his employee. Upon conviction of misrepresentation of the species of fish sold by any fish peddler licensed hereunder or his employee, his license shall be revoked, and such licensee shall not be eligible to obtain a fish peddler's license for the period of one year after said revocation. Misrepresentation shall include the following acts in addition to any other acts constituting misrepresentation in fact: (1) The designation of any fish by any name other than its common name in Minnesota; (2) The designation of any fish by any other name than its common name in the locality where it was taken if it is not generally known by any common name in Minnesota.
