

- (a) For the purpose of selling to retailers, \$25;
- (b) For the purpose of retail selling only, \$5.
- (2) To buy fish from licensed commercial fishermen on Lake of the Woods, Namakan, Sand Point, or Rainy Lake:
  - (a) Wholesale fish buyer's license, \$100;
  - (b) Fish buyer's license to ship from one place to another on international waters only, \$10.
- (3) To tan or dress raw furs, \$2;
- (4) Fish peddler's license, to peddle with the use of a motor vehicle, any fish lawfully salable within the state, \$5. *It shall be unlawful to misrepresent the species of any fish sold by any licensed fish peddler or his employee. Upon conviction of misrepresentation of the species of fish sold by any fish peddler licensed hereunder or his employee, his license shall be revoked, and such licensee shall not be eligible to obtain a fish peddler's license for the period of one year after said revocation. Misrepresentation shall include the following acts in addition to any other acts constituting misrepresentation in fact: (1) The designation of any fish by any name other than its common name in Minnesota; (2) The designation of any fish by any other name than its common name in the locality where it was taken if it is not generally known by any common name in Minnesota.*

CHAPTER 503—H. F. No. 647

*An act relating to education; prescribing time for filing applications by candidates in school district elections; amending Minnesota Statutes 1961, Section 123.32, Subdivision 4.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 123.32, Subdivision 4, is amended to read:

Subd. 4. **School districts; elections; filing by candidates.** At the annual election board members shall be elected to fill vacancies on the board caused by expiration of term on July 1 next following the election. Any person desiring to be a candidate for a district office at the election shall file with the clerk of the district a written

application to be placed on the ballot for such office, or any five voters of the district may file such written application for or on behalf of any qualified voter in the district that they desire shall be such candidate. The application shall be filed not more than ~~30~~ 45 nor less than ~~12~~ 21 days before the election.

Sec. 2. *The effective date of this act shall be January 1, 1966.*

## CHAPTER 504—H. F. No. 762

*An act relating to business corporations; amending Minnesota Statutes 1961, Sections 301.03; 301.04; 301.12; 301.26, Subdivisions 2 and 11; 301.28, Subdivisions 1 and 4; 301.37, Subdivision 3; 301.40; 301.42, Subdivisions 1 and 5; 301.60, Subdivision 9; and Chapter 301, by adding a section.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 301.03, is amended to read:

**301.03 Business corporations; revision; purpose of incorporation and qualification of incorporators.** ~~Three~~ *One* or more natural persons of full age may form a corporation under sections 301.01 to 301.61 for any lawful business purposes; provided that banks, savings banks, trust companies, building, loan, and savings associations, and insurance companies shall not be formed under the provisions of these sections; and, provided that where other statutes prescribe a special procedure for the incorporation of designated classes of corporations, such corporations shall be formed under such statutes and not under these sections.

*The articles of incorporation of a corporation formed under sections 301.01 to 301.61 may state that the corporation has general business purposes; and corporations with purposes so designated shall have unlimited power to engage in, and to do any lawful act concerning, any and all lawful businesses for which corporations may be organized under these sections.*
