CHAPTER 540—S. F. No. 1777

An act relating to the West Saint Paul firemen's relief association; establishing the contributions of the members and the city of West Saint Paul; authorizing the payment of disability pensions; and widows and childrens pensions.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **West St. Paul, city of; firemen's relief.** It shall be the duty of the city treasurer of West Saint Paul to deduct each month, from the monthly pay of each member of the West Saint Paul firemen's relief association, a sum equal to five percent of the basic monthly pay of a first grade fireman, and pay the same to the treasurer of the West Saint Paul firemen's relief association for the credit to the special fund of said association.

Sec. 2. The city shall annually contribute and pay to the treasurer of the West Saint Paul firemen's relief association, for credit to the special fund of said association, a sum equal to nine percent of the basic annual salary of a first grade fireman for each full-time member of the association who is employed full-time in the fire department of the city of West Saint Paul, during the entire year.

Sec. 3. The West Saint Paul firemen's relief association may pay monthly a disability pension, in an amount not exceeding 40 percent of a first grade fireman's monthly salary in the city of West Saint Paul, to disabled members of said association.

Sec. 4. The West Saint Paul firemen's relief association may pay a widow's and children's pension in an amount not to exceed the following: To a widow, a monthly sum not exceeding 30 percent of a first grade fireman's monthly salary, and for children of a deceased member of the association, an amount not exceeding five percent per child per month of a first grade fireman's monthly salary. And provided further, in no event, shall the widow and chil-

dren's pension combined, or in any combination, exceed 40 percent of a first grade fireman's salary.

Sec. 5. The city of West Saint Paul shall, in no way, be liable to the West Saint Paul firemen's relief association, it's members, widows of members, children of members, or others for payment to the association to any such beneficiaries or any obligations of the association, except as provided in section 2 hereof.

Sec. 6. This act shall be effective upon its approval by the city council of the city of West Saint Paul and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 541—S. F. No. 1827

An act relating to the salaries of the county commissioners of Stearns county; repealing Laws 1963, Chapter 510, Section 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Stearns county; commissioners' salaries.** The annual salaries of each of the members of the board of county commissioners of Stearns county shall be set by said board at a sum not to exceed \$3,600, which sum shall be payable in equal monthly installments. Each member of the board of county commissioners shall be allowed a sum not to exceed \$900 per year, which said sum shall be payable in equal monthly installments as and for expense account.

Sec. 2. The salary and expense provided in section 1 shall be in lieu of all other emoluments, per diems, or mileage now allowed by law.

Sec. 3. Laws 1963, Chapter 510, Section 2, is hereby repealed.

Sec. 4. This act is effective upon its approval by a majority of the members of the county board of Stearns county and upon compliance with Minnesota Statutes, Section 645.021.
